- $\frac{4.(d)}{d}$ Any person using a headset in conjunction with a cellular telephone that only provides sound through one ear and allows surrounding sounds to be heard with the other ear.
- 5.(e) Any person using a headset in conjunction with communicating with the central base operation that only provides sound through one ear and allows surrounding sounds to be heard with the other ear.
- (c) (3) The Department of Highway Safety and Motor Vehicles shall promulgate, by administrative rule, standards and specifications for headset equipment the use of which is permitted under this <u>subsection</u> section. The department shall inspect and review all such devices submitted to it and shall publish a list by name and type of approved equipment.
- (2) (a) No person shall operate a moving motor vehicle while reading, manually writing or typing, or sending a message on an electronic wireless communications device.
- (b) This subsection does not apply to a person operating an authorized emergency vehicle or using an electronic wireless communications device to:
 - 1. Report illegal activity;

- 2. Summon medical or other emergency help; or
- 3. Prevent injury to a person or property.
- (3)(4) A violation of this section is a noncriminal traffic infraction, punishable as a nonmoving violation as provided in chapter 318.
 - Section 2. This act shall take effect October 1, 2010.
