#### I. **Summary:**

This bill would change the names of Palm Beach Community College to Palm Beach State College and Seminole Community College to Seminole State College of Florida.

This bill amends sections 288.8175 and 1000.21, Florida Statutes.

#### II. **Present Situation:**

# Changing a College's Name

A community college may change its name to college or state college<sup>1</sup> if it has been authorized to grant baccalaureate degrees<sup>2</sup> and has been accredited to do so by the Commission on Colleges of the Southern Association of Colleges and Schools, or, alternatively, with board-of-trustees and

The statute also provides exceptions to the requirements for notice and State Board of Education approval.

State Board of Education approval. The college must seek a statutory codification of the name in the year following the college's name change.

#### Palm Beach Community College

Palm Beach Community College serves Palm Beach County.<sup>3</sup> On February 19, 2008, the State Board of Education approved the college's application to establish a bachelor of applied science program in supervision and management. In September 2009, the college's board of trustees approved a motion to rename the institution Palm Beach State College.

#### **Seminole Community College**

Seminole Community College serves Seminole County. On January 21, 2009, the State Board of Education approved the college's application to establish a bachelor of applied science program in interior design. In September 2009, the college's board of trustees approved a motion to rename the institution Seminole State College of Florida.

Palm Beach Community College and Seminole Community College have met the statutory requirements for changing their names. They have been authorized by the State Board of Education to grant baccalaureate degrees and have been accredited to do so by the Commission on Colleges of the Southern Association of Colleges and Schools. The boards of trustees of the respective colleges have approved new college names. This bill would codify the name changes.

## III. Effect of Proposed Changes:

The bill would change the names of Palm Beach Community College to Palm Beach State College and Seminole Community College to Seminole State College of Florida.
