Section 2. Paragraph (b) of subsection (1) of section 381.0072, Florida Statutes, is amended to read:

381.0072 Food service protection.-It shall be the duty of 16 17 the Department of Health to adopt and enforce sanitation rules 18 consistent with law to ensure the protection of the public from 19 food-borne illness. These rules shall provide the standards and 20 requirements for the storage, preparation, serving, or display 21 of food in food service establishments as defined in this 22 section and which are not permitted or licensed under chapter 23 500 or chapter 509.

24 (1) DEFINITIONS.-As used in this section, the term: 25 (b) "Food service establishment" means any facility, as 26 described in this paragraph, where food is prepared and intended 27 for individual portion service, and includes the site at which 28 individual portions are provided. The term includes any such 29 facility regardless of whether consumption is on or off the premises and regardless of whether there is a charge for the 30 31 food. The term includes detention facilities, child care facilities, schools, institutions, civic or fraternal 32 33 organizations, bars and lounges and facilities used at temporary 34 food events, mobile food units, and vending machines at any facility regulated under this section. The term does not include 35 36 private homes where food is prepared or served for individual 37 family consumption; nor does the term include churches, synagogues, or other not-for-profit religious organizations as 38 39 long as these organizations serve only their members and guests and do not advertise food or drink for public consumption, or 40 41 any facility or establishment permitted or licensed under
