3 ss. 11.2421, 11.2422, 11.2424, and 11.2425, F.S.; adopting  
4 the Florida Statutes 2010 and designating the portions  
5 thereof that are to constitute the official law of the  
6 state; providing that the Florida Statutes 2010 shall be  
7 effective immediately upon publication; providing that  
8 general laws enacted during the 2009 regular session and  
9 prior thereto and not included in the Florida Statutes  
10 2010 are repealed; providing that general laws enacted  
11 during the December 3-8, 2009, special session and the  
12 2010 regular session are not repealed by this adoption  
13 act; providing an effective date.

15 Be It Enacted by the Legislature of the State of Florida:

17 Section 1. Section 11.2421, Florida Statutes, is amended  
18 to read:

19 11.2421 Florida Statutes 2010 ~~2009~~ adopted.—The  
20 accompanying revision, consolidation, and compilation of the  
21 public statutes of 2009 ~~2008~~ of a general and permanent nature,  
22 excepting tables, rules, indexes, and other related matter  
23 contained therein, prepared by the Office of Legislative  
24 Services under the provisions of s. 11.242, together with  
25 corrections, changes, and amendments to and repeals of  
26 provisions of Florida Statutes 2009 ~~2008~~ enacted in additional  
27 reviser's bill or bills by the 2010 ~~2009~~ Legislature, is adopted  
28 and enacted as the official statute law of the state under the

29 title of "Florida Statutes 2010 ~~2009~~" and shall take effect  
30 immediately upon publication. Said statutes may be cited as  
31 "Florida Statutes 2010 ~~2009~~," "Florida Statutes," or "F.S. 2010  
32 ~~2009~~."

33 Section 2. Section 11.2422, Florida Statutes, is amended  
34 to read:

35 11.2422 Statutes repealed.—Every statute of a general and  
36 permanent nature enacted by the State or by the Territory of  
37 Florida at or prior to the 2009 ~~2008~~ regular legislative  
38 session, and every part of such statute, not included in Florida  
39 Statutes 2010 ~~2009~~, as adopted by s. 11.2421, as amended, or  
40 recognized and continued in force by reference therein or in ss.  
41 11.2423 and 11.2424, as amended, is repealed.

42 Section 3. Section 11.2424, Florida Statutes, is amended  
43 to read:

44 11.2424 Laws not repealed.—Laws enacted at the December 3-  
45 8, 2009, special session and the 2010 January 5-14, 2009,  
46 ~~special session and the 2009~~ regular session are not repealed by  
47 the adoption and enactment of the Florida Statutes 2010 ~~2009~~ by  
48 s. 11.2421, as amended, but shall have full effect as if enacted  
49 after its said adoption and enactment.

50 Section 4. Section 11.2425, Florida Statutes, is amended  
51 to read:

52 11.2425 Rights reserved under repealed statutes.—The  
53 repeal of any statute by the adoption and enactment of Florida  
54 Statutes 2010 ~~2009~~, by s. 11.2421, as amended, shall not affect  
55 any right accrued before such repeal or any civil remedy where a  
56 suit is pending.
