9 (2) Unless specifically exempted, all eligible persons
10 must be enrolled in a developmental disabilities comprehensive
11 long-term care plan or a developmental disabilities long-term
12 care plan. Medicaid recipients who are residents of a
13 developmental disability center, including Sunland Center in
14 Marianna and Tacachale Center in Gainesville, are exempt from
15 mandatory enrollment but may voluntarily enroll in a long-term
16 care plan.

19 409.988 Benefits.-Managed care plans shall cover, at a
20 minimum, the services in this section. Plans may customize
21 benefit packages or offer additional benefits to meet the needs
22 of enrollees in the plan.

61 to s. 409.988, or developmental disabilities comprehensive long-
62 term care plans that cover benefits pursuant to ss. 409.973 and
63 409.988. Other qualified plans may only be developmental
64 disabilities comprehensive long-term care plans that cover
65 benefits pursuant to ss. 409.973 and 409.988.
