**Senate Amendment (with title amendment)**

Delete lines 31 - 84  
and insert:  
contributions shall be distributed by the department to Lauren's Kids, Inc., a corporation not for profit under s. 501(c)(3) of the Internal Revenue Code. The funds shall be used by the organization for the prevention of childhood sexual abuse.

For the purpose of applying the service charge provided in s. 215.20, contributions received under this subsection are not income of a revenue nature.

25 contribution shall be distributed to the Florida Council of the  
26 Blind.

27 (c) A voluntary contribution of \$2 per applicant, which  
28 shall be distributed to the Hearing Research Institute,

30 (d) A voluntary contribution of \$1 per applicant, which
