(p) Notwithstanding s. 26 of chapter 2010-223, Laws of Florida, the application form for motor vehicle registration and renewal registration must include a provision permitting a voluntary contribution of \$1 or more per applicant, to be distributed to the Auto Club South Traffic Safety Foundation, a nonprofit organization.
