5 (6) The Legislature may, at its discretion, review any 6 cooperative reciprocal agreement entered into by the Chief 7 Financial Officer and the office with another state or group of 8 states. If the Legislature determines that the cooperative 9 reciprocal agreement is not in the best interest of the state, the Legislature shall instruct the Chief Financial Officer and 10 11 the office to withdraw from the cooperative reciprocal agreement, pursuant to any notice provisions required by any 12 13 such agreement.
