Choose Life, Inc., Each county shall 18 distribute the funds to nongovernmental, not-for-profit agencies 19 that assist within the county, which agencies' services are 20 21 limited to counseling and meeting the physical needs of pregnant 22 women who are making an adoption plan for their children committed to placing their children for adoption. Funds may not 23 24 be distributed to any agency that is involved or associated with 25 abortion activities, including counseling for or referrals to 26 abortion clinics, providing medical abortion-related procedures, or proabortion advertising, and funds may not be distributed to 27 any agency that charges women for services received. 28

29 1. Agencies that receive the funds must use at least 70 percent of the funds to provide for the material needs of 30 31 pregnant women who are making an adoption plan for their 32 children committed to placing their children for adoption, 33 including, but not limited to, clothing, housing, medical care, food, utilities, and transportation. Such funds may also be 34 35 expended on birth mothers for 60 days after delivery and on 36 infants awaiting placement with adoptive parents.

37 2.
