A bill to be entitled

An act relating to nursing services; creating s. 395.01922, F.S.; providing definitions; requiring that hospitals establish nurse staffing collaborative councils; providing for membership and responsibilities; requiring the council to produce annual hospital nurse staffing plans; requiring the chief nurse executive to communicate with the council to ensure appropriate implementation of the nurse staffing plan; requiring that the council conduct a semiannual review of the nurse staffing plan; requiring the nurse staffing plan to be reviewed with the nurse personnel and made available to the public upon request; providing an effective date.

WHEREAS, research demonstrates that registered nurses play a critical role in patient safety and quality of care, and hospitals are employing multiple strategies to recruit and retain nurses, and

WHEREAS, the implementation of evidence-based nurse staffing plans to foster safe, high-quality patient care and increase job satisfaction for nurses is crucial, and

WHEREAS, hospitals and nursing organizations share a mutual interest in patient-safety initiatives that create a healthy environment for nurses and provide for the safe care of patients, and

WHEREAS, in order to ensure safe, quality patient care, support the retention of registered nurses, and promote evidence-based nurse staffing, the Legislature intends to

establish a mechanism whereby nurses and hospital leadership participate in a joint process regarding nurse staffing plan decisions, NOW, THEREFORE,

Be It Enacted by the Legislature of the State of Florida:

- Section 1. Section 395.01922, Florida Statutes, is created to read:
  - 395.01922 Nurse staffing collaborative councils.-
  - (1) As used in this section, the term:
- (a) "Acuity" means the level of patient need for nursing care, as determined by the nursing assessment.
- (b) "Nurse staffing collaborative council" means the collaborative council established by a hospital under this section.
- (c) "Nursing personnel" means registered nurses, licensed practical nurses, certified nursing assistants, and unlicensed assistive personnel providing direct patient care.
- (d) "Nursing-sensitive quality indicator" means an indicator that captures the quality of care or the outcomes most affected by nursing care.
- (e) "Patient care unit" means any unit or area of the hospital where registered nurses provide care to patients.
- (f) "Skill mix" means the number and relative percentages of registered nurses, licensed practical nurses, certified nursing assistants, and unlicensed assistive personnel among the total number of nursing personnel.
  - (2) By September 1, 2011, each hospital licensed under

this chapter shall establish a nurse staffing collaborative council by creating a new collaborative council or assigning the functions of a nurse staffing collaborative council to an existing council or committee. Membership of the nurse staffing collaborative council shall be determined by the chief nursing executive and shall include nurses currently participating in direct patient care.

- (3) Primary responsibilities of the nurse staffing collaborative council shall include the development and oversight of an annual patient care unit and shift-based nurse staffing plan based on the needs of patients, which shall be used as the primary factor in developing the nurse staffing budget. Factors to be considered in the development of the plan shall include, but are not limited to:
- (a) Census information, including the total number of patients in the unit for each shift, and activity in the unit, such as patient discharges, admissions, and transfers.
- (b) The acuity level of all patients and the nature of the care to be delivered for each shift.
  - (c) The skill mix.

- (d) The level of education, training, and experience of the nursing personnel providing care.
  - (e) The need for specialized equipment.
- (f) The physical layout and design of the patient care unit, including, but not limited to, placement of patient rooms, treatment areas, nursing stations, medication preparation areas, and equipment.
  - (g) Staffing guidelines adopted or published by national

professional nursing associations, specialty nursing
organizations, and other health care professional organizations.

(h) Hospital finances and resources.

- (i) Level of technology and support.
- (4) The nurse staffing collaborative council shall produce an annual nurse staffing plan for the hospital. The chief nurse executive shall communicate and collaborate with the council to ensure the safe and appropriate implementation of a staffing plan.
- (5) The nurse staffing collaborative council shall conduct a semiannual review of the staffing plan with regard to patient needs and evidence-based staffing information, including the nursing-sensitive quality indicators collected by the hospital.
- (6) The staffing plan shall be reviewed annually with nursing personnel in each patient care area and the plan shall be shared with the community upon request.
  - Section 2. This act shall take effect July 1, 2011.
