19 WHEREAS, it is the intent of the Legislature that a veteran
20 not be charged more than \$2 for obtaining the "V" code
21 designation on his or her driver license or identification card,
22 and that an additional fee may not be charged for the
23 designation if the veteran previously paid the designation fee,

32 | (b) A capital "V" shall be exhibited on the identification
 33 | card of a veteran upon the payment of an additional \$1 fee for
 34 | the license and the presentation of a copy of the person's DD
 35 | Form 214, issued by the United States Department of Defense, or
 36 | another acceptable form specified by the Department of Veterans'
 37 | Affairs. Until a veteran's identification card is next renewed,
 38 | the veteran may have the capital "V" designation added to his or
 39 | her identification card upon surrender of his or her current
 40 | identification card, payment of a \$2 fee to be deposited into
 41 | the Highway Safety Operating Trust Fund, and presentation of a
 42 | copy of his or her DD Form 214 or another acceptable form
 43 | specified by the Department of Veterans' Affairs. If the
 44 | applicant is not conducting any other transaction affecting the
 45 | identification card, a replacement identification card may be
 46 | issued with the capital "V" designation without payment of the
 47 | fee required in s. 322.21(1)(f)3.

58 the veteran may have the capital "V" designation added to his or
59 her license upon surrender of his or her current license,
60 payment of a \$2 fee to be deposited into the Highway Safety
61 Operating Trust Fund, and presentation of a copy of his or her
62 DD Form 214 or another acceptable form specified by the
63 Department of Veterans' Affairs. If the applicant is not
64 conducting any other transaction affecting the driver license, a
65 replacement license may be issued with the capital "V"
66 designation without payment of the fee required in s.
67 322.21(1)(e).

68 Section 3. This act shall take effect July 1, 2012.
