25	receiving the highest number of votes on the first ballot. The

27	members, including appointees, to the board of supervisors of

29	(1) The board member seats shall be numbered seats 1, 2,
30	3, 4, and 5, respectively.
31	(a) The seats held by the board members whose terms expire
32	in 2012 shall be designated seat 1 and seat 2, respectively.

34	electors of the district, as described in paragraph (3), which
