21	department are required to ensure that all items used by the
22	department and stored on a truck are appropriately secured to
23	the truck, and
24	WHEREAS, one such item used by the department and stored on
25	the truck was a 12-foot extension ladder stored on the top of
26	the truck, and
27	WHEREAS, the department's employee failed to ensure that
28	the ladder was secured to the truck before leaving the
29	department's maintenance yard, and

24-00171-12 201230 30 WHEREAS, thereafter, while the employee traveled northbound on Interstate 75, the extension ladder flew from the roof of the 31 32 truck into the northbound traffic following the department's 33 truck, and 34 WHEREAS, the driver of the vehicle traveling behind the 35 department's truck swerved to avoid hitting the extension 36 ladder, which was ejected directly at the driver in her lane of 37 traffic, and WHEREAS, as a result of the swerving movements, the driver 38 39 of the vehicle behind the department's truck lost control of her vehicle, veered to the left, crossed the Interstate 75 median, 40 41 and struck Dr. Aversa's vehicle, killing Dr. Aversa instantly, 42 and 43 WHEREAS, as a result of these events, the Estate of Dr. 44 Aversa brought suit against the Department of Transportation for 45 the negligence causing the death of Dr. Aversa, and WHEREAS, after 3 years of litigation, the department 46 47 admitted liability for the accident and agreed to settle the case, and 48 WHEREAS, the parties agreed to a consent judgment solely 49 50 against the department, with no finding of comparative 51 negligence against any other party, in the amount of \$797,500, 52 and 53 WHEREAS, the Department of Transportation has paid \$100,000 54 to the Estate of Dr. Sherrill Lynn Aversa under the statutory 55 limits of liability set forth in s. 768.28, Florida Statutes, 56 NOW, THEREFORE, 57 58 Be It Enacted by the Legislature of the State of Florida:

60	Section 1. The facts stated in the preamble to this act are
61	found and declared to be true.
62	Section 2. The Executive Office of the Governor is directed
63	to establish spending authority from unappropriated trust fund
64	balances of the Department of Transportation in the amount of
65	\$697,500 to a new category titled "Relief: Estate of Dr.
66	Sherrill Lynn Aversa" as compensation to the Estate of Dr.
67	Sherrill Lynn Aversa for the death of Dr. Aversa, which amount
68	includes attorney's fees and costs.
69	Section 3. The Chief Financial Officer is directed to draw
70	a warrant in favor of the Estate of Dr. Sherrill Lynn Aversa in
71	the sum of \$697,500 upon funds of the Department of
72	Transportation not otherwise encumbered, and the Chief Financial
73	Officer is directed to pay the same out of such funds in the
74	State Treasury.
75	Section 4. The amount paid by the Department of
76	Transportation pursuant to s. 768.28, Florida Statutes, and the
77	amount awarded under this act are intended to provide the sole
78	compensation for all present and future claims arising out of
79	the factual situation described in this act which resulted in
80	the death of Dr. Sherrill Lynn Aversa. The total amount paid for
81	attorney's fees, lobbying fees, costs, and other similar
82	expenses relating to this claim may not exceed 25 percent of the
83	amount awarded under this act.
84	Section 5. This act shall take effect upon becoming a law.
