**I. Summary:**

This bill creates the One-Stop Business Registration Portal Clearing Trust Fund within the Department of Revenue, effective July 1, 2012. The trust fund is to be used as a depository for receipts generated through the utilization of the One-Stop Business Registration Portal to be established in section 288.109, F.S. The department will distribute the moneys collected in the trust fund to the appropriate agencies and accounts.

This bill is effective July 1, 2012, if Senate Proposed Bill 7084 or similar legislation is adopted in the same legislative session or an extension thereof and becomes law.

This bill creates s. 215.1995 of the Florida Statutes.

**II. Present Situation:**

The creation of this trust fund will serve as a depository for receipts obtained through the One-Stop Business Registration Portal, established under s. 288.109, F.S., and for subsequent transfer or distribution of those fees to appropriate agencies and accounts.

Section 19(f), Art. III of the State Constitution requires that trust funds be created by a three-fifths vote of the membership in each house and be in a separate bill for the sole purpose of creating that trust fund.

**III. Effect of Proposed Changes:**

This bill creates the One-Stop Business Registration Portal Trust Fund within the Department of Revenue, effective July 1, 2012. The trust fund is to be used as a depository for receipts generated through the utilization of the One-Stop Business Registration Portal to be established in section 288.109, F.S. The department will distribute the moneys collected in the trust fund to the appropriate agencies and accounts in the month following receipt.

The trust fund will terminate in four years, on July 1, 2016, pursuant to s. 19 (f)(2), Art. III of the State Constitution, unless terminated sooner or recreated by the Legislature.

The creation of this trust fund is directly linked to Senate Proposed Bill 7084, which creates the One Stop Business Registration Portal within the Department of Revenue.

This bill, creating a new trust fund, must pass by a three-fifths vote of the membership of each house of the legislature to become law pursuant to s. 19 (f), Art.III of the State Constitution.
