(1) (a) <u>Except as provided in subsection (2)</u>, level 2 background screening pursuant to chapter 435 is required for direct service providers. Background screening includes employment history checks as provided in s. 435.03(1) and local criminal records checks through local law enforcement agencies.

(b) For purposes of this section, the term "direct service provider" means a person 18 years of age or older who, pursuant to a program to provide services to the elderly, has direct, face-to-face contact with a client while providing services to the client <u>and or</u> has access to the client's living areas, or to the client's funds, or personal property, or personal identification information as defined in s. 817.568.
