For high school students graduating in the 2013-2014 academic year and thereafter, the student must earn an SAT score of <u>1090</u> 1170 which corresponds to the <u>64th</u> 75th SAT percentile rank or a concordant ACT score of <u>24</u> 26 or the student in a home education program whose parent cannot document a collegepreparatory curriculum must earn an SAT score of <u>1170</u> 1220 or a concordant ACT score of <u>25</u> 27.
