insert:

Section 29. Subsection (71) of section 320.08058, Florida Statutes, is amended to read

320.08058 Specialty license plates.—

(71) HISPANIC ACHIEVERS LICENSE PLATES.—

(a) Notwithstanding the requirements of s. 320.08053, the department shall develop a Hispanic Achievers license plate as provided in this section. The plate must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the words "Hispanic

14 Achievers" must appear at the bottom of the plate.

15 (b) The proceeds from the license plate annual use fee
16 shall be distributed to National Hispanic Corporate Achievers,
17 Inc., a nonprofit corporation under s. 501(c)(3) of the Internal
18 Revenue Code, to fund grants to nonprofit organizations to
19 operate programs and provide scholarships and for marketing the
20 Hispanic Achievers license plate. National Hispanic Corporate
21 Achievers, Inc., shall establish a Hispanic Achievers Grant
22 Council that shall provide recommendations for statewide grants
23 from available Hispanic Achievers license plate proceeds to
24 nonprofit organizations for programs and scholarships for
25 Hispanic and minority Floridians. National Hispanic Corporate
26 Achievers, Inc., shall also establish a Hispanic Achievers
27 License Plate Fund. Moneys in the fund shall be used by the
28 grant council as provided in this paragraph. All funds received
29 under this subsection must be used in this state.

30 (c) National Hispanic Corporate Achievers, Inc., may retain
31 all proceeds from the annual use fee until documented startup
32 costs for developing and establishing the plate have been
33 recovered. Thereafter, the proceeds from the annual use fee
34 shall be used as follows:

35 1. Up to 5 ~~10~~ percent of the proceeds may be used for the
36 cost of administration of the Hispanic Achievers License Plate
37 Fund, the Hispanic Achievers Grant Council, and related matters.

38 2. Funds may be used as necessary for annual audit or
39 compliance affidavit costs.

40 3. Up to 20 percent of the proceeds may be used to market
41 and promote the Hispanic Achievers license plate.

42 ~~4.3-~~ Twenty-five percent of the proceeds shall be used by

43 the Hispanic Corporate Achievers, Inc., located in Seminole
44 County, for grants.

45 ~~5.4.~~ The remaining proceeds shall be available to the
46 Hispanic Achievers Grant Council to award grants for services,
47 programs, or scholarships for Hispanic and minority individuals
48 and organizations throughout Florida. All grant recipients must
49 provide to the Hispanic Achievers Grant Council an annual
50 program and financial report regarding the use of grant funds.
51 Such reports must be available to the public.
