Section 2. Subsection (1) of section 328.72, Florida Statutes, is amended to read

328.72 Classification; registration; fees and charges; surcharge; disposition of fees; fines; marine turtle stickers.-

(1) VESSEL REGISTRATION FEE.-

~~(a)~~ Vessels that are required to be registered shall be classified for registration purposes according to the following schedule, and the registration certificate fee shall be in the

14 Class A-1-Less than 12 feet in length, and all canoes to
15 which propulsion motors have been attached, regardless of
16 length: \$5.50 for each 12-month period registered.

17 Class A-2-12 feet or more and less than 16 feet in length:
18 \$16.25 for each 12-month period registered.

19 (To county): 2.85 for each 12-month period registered.

20 Class 1-16 feet or more and less than 26 feet in length:
21 \$28.75 for each 12-month period registered.

22 (To county): 8.85 for each 12-month period registered.

23 Class 2-26 feet or more and less than 40 feet in length:
24 \$78.25 for each 12-month period registered.

25 (To county): 32.85 for each 12-month period registered.

26 Class 3-40 feet or more and less than 65 feet in length:
27 \$127.75 for each 12-month period registered.
