Senate Amendment (with title amendment)

Delete lines 856 - 906

and insert:

(b) Until 7 p.m. on the day of the election, the supervisor shall allow an elector who has returned an absentee ballot that does not include the elector's signature to complete an affidavit in order to cure the unsigned absentee ballot. (c) The elector shall provide identification to the supervisor and must complete an absentee ballot affidavit in substantially the following form:
