9 (71) HISPANIC ACHIEVERS LICENSE PLATES.—

10 (a) Notwithstanding the requirements of s. 320.08053, the
11 department shall develop a Hispanic Achievers license plate as
12 provided in this section. The plate must bear the colors and
13 design approved by the department. The word "Florida" must
14 appear at the top of the plate, and the words "Hispanic
15 Achievers" must appear at the bottom of the plate.

16 (b) The proceeds from the license plate annual use fee
17 shall be distributed to National Hispanic Corporate Achievers,
18 Inc., a nonprofit corporation under s. 501(c)(3) of the Internal
19 Revenue Code, to fund grants to nonprofit organizations to
20 operate programs and provide scholarships and for marketing the
21 Hispanic Achievers license plate. National Hispanic Corporate
22 Achievers, Inc., shall establish a Hispanic Achievers Grant
23 Council that shall provide recommendations for statewide grants
24 from available Hispanic Achievers license plate proceeds to
25 nonprofit organizations for programs and scholarships for
26 Hispanic and minority Floridians. National Hispanic Corporate
27 Achievers, Inc., shall also establish a Hispanic Achievers
28 License Plate Fund. Moneys in the fund shall be used by the
29 grant council as provided in this paragraph. All funds received
30 under this subsection must be used in this state.

31 (c) National Hispanic Corporate Achievers, Inc., may
32 retain all proceeds from the annual use fee until documented
33 startup costs for developing and establishing the plate have
34 been recovered. Thereafter, the proceeds from the annual use fee
35 shall be used as follows:

36 1. Up to 5 ~~10~~ percent of the proceeds may be used for the
37 cost of administration of the Hispanic Achievers License Plate
38 Fund, the Hispanic Achievers Grant Council, and related matters.

39 2. Funds may be used as necessary for annual audit or
40 compliance affidavit costs.

41 3. Up to 20 percent of the proceeds may be used to market
42 and promote the Hispanic Achievers license plate.

43 ~~4.3.~~ Twenty-five percent of the proceeds shall be used by
44 the Hispanic Corporate Achievers, Inc., located in Seminole
45 County, for grants.

46 ~~5.4.~~ The remaining proceeds shall be available to the
47 Hispanic Achievers Grant Council to award grants for services,
48 programs, or scholarships for Hispanic and minority individuals
49 and organizations throughout Florida. All grant recipients must
50 provide to the Hispanic Achievers Grant Council an annual
51 program and financial report regarding the use of grant funds.
