 7 Section 1. Section 1 of chapter 2012-256, Laws of Florida,
 8 is amended to read:

9 Section 1. Extension of Acme Improvement District
 10 boundaries.—The lands commonly known as the "Wellington Medical
 11 Arts District," more particularly described below, shall be
 12 added to the territorial limits of the Acme Improvement
 13 District, a dependent district of the Village of Wellington,
 14 existing in Palm Beach County, as codified under chapter 2003-
 15 330, Laws of Florida, and shall be removed from the territorial
 16 limits of the Lake Worth Drainage District, a corporation under
 17 the drainage laws of the state, existing in Palm Beach County,

18 as codified under chapter 98-525, Laws of Florida. The purpose
19 of the transfer of property from the Lake Worth Drainage
20 District to the Acme Improvement District is to facilitate the
21 development of the Wellington Medical Arts District as a
22 premiere wellness, health care treatment, medical education, and
23 research destination. The achievement of this development will
24 create local and regional jobs and greatly expand educational
25 opportunities in the area. The inclusion of these lands within
26 the Acme Improvement District will create the opportunity to
27 enhance and expedite the delivery of infrastructure and services
28 to the Wellington Medical Arts District. The Wellington Medical
29 Arts District is more particularly described as follows:
