Section 1. Section 318.195, Florida Statutes, is created to read:

318.195 Enhanced penalties for moving violations causing 21 injury or death.-

(1) A person who commits a moving violation that causes serious bodily injury, as defined in s. 316.1933, to a vulnerable road user commits a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. 775.083, and, upon conviction, shall pay a fine of not less than \$1,500, serve a minimum of 30 days of house arrest, and attend a driver improvement course. The court shall also revoke the person's driver license for at least 30 days.

(2) A person who commits a moving violation that causes the death of a vulnerable road user commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s.

775.083, and, upon conviction, shall pay a fine of not less than \$5,000, serve a minimum of 180 days of house arrest, and, in lieu of the requirements of s. 322.0261, attend an advanced driver improvement course. The court shall also revoke the person's driver license for at least 1 year.

- (3) As used in this section, the term "vulnerable road user" means:
- (a) A pedestrian, including a person engaged in work upon a highway, or in work upon utility facilities along a highway, or engaged in the provision of emergency services within the right-of-way;
- (b) A person operating a bicycle, motorcycle, scooter, or moped lawfully on the roadway;
  - (c) A person riding an animal; or
- (d) A person lawfully operating any of the following on a public right-of-way, crosswalk, or shoulder of the roadway:
- 1. A farm tractor or similar vehicle designed primarily for farm use;
  - 2. A skateboard, roller skates, or in-line skates;
  - 3. A horse-drawn carriage;
  - 4. An electric personal assistive mobility device; or
- 54 5. A wheelchair.
  - (4) This section does not prohibit a person from being charged with, convicted of, or punished for any other violation of law.
    - Section 2. This act shall take effect July 1, 2014.
