Senator Bradley moved the following:

**Senate Amendment (with title amendment)**

Delete lines 69 - 91

and insert:

hydrocodone, or any salt, derivative, isomer, or salt of an isomer thereof, or 14 grams or more of any mixture containing any such substance, commits a felony of the first degree, which felony shall be known as "trafficking in hydrocodone," punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

If the quantity involved:

a. Is 14 grams or more, but less than 28 grams, such person



12 shall be sentenced to a mandatory minimum term of imprisonment  
13 of 3 years and shall be ordered to pay a fine of \$50,000.

14 b. Is 28 grams or more, but less than 50 grams, such person  
15 shall be sentenced to a mandatory minimum term of imprisonment  
16 of 7 years and shall be ordered to pay a fine of \$100,000.

17 c. Is 50 grams or more, but less than 200 grams, such  
18 person shall be sentenced to a mandatory minimum term of  
19 imprisonment of 15 years and shall be ordered to pay a fine of  
20 \$500,000.

21 d. Is 200 grams or more, but less than 30 kilograms, such  
22 person shall be sentenced to a mandatory minimum term of  
23 imprisonment of 25 years and shall be ordered to pay a fine of  
24 \$750,000.

25 3. A person who knowingly sells, purchases, manufactures,  
26 delivers, or brings into this state, or who is knowingly in  
27 actual or constructive possession of, 7 grams or more of  
28 oxycodone, or any salt, derivative, isomer, or salt of an isomer  
29 thereof, or 7 grams or more of any mixture containing any such
