7 6. Notwithstanding subparagraph 5., a business owner or
 8 lessee may authorize the removal of a vehicle or vessel by a
 9 towing company when a the vehicle or vessel is parked in such a
 10 manner that restricts the normal operation of business; is and
 11 if a vehicle or vessel parked on a public right-of-way in a
 12 manner that obstructs access to a private driveway; or has been
 13 parked or stored on private property for a period exceeding 5
 14 days, the owner or, lessee, or agent of the owner or lessee, of
 15 the real property may have the vehicle or vessel removed by a
 16 towing company upon signing an order that the vehicle or vessel
 17 be removed without a posted tow-away zone sign. However, the 5-

18 day period after which the owner or lessee, or agent of the
19 owner or lessee, of the real property may have the vehicle or
20 vessel removed without tow-away zone signage does not begin
21 until both of the following requirements are met:

22 a. Such owner, lessee, or agent attaches to the vehicle or
23 vessel with adhesive material a notice that the vehicle or
24 vessel will be towed or removed from the property. The notice
25 must:

26 I. In the case of a vehicle, be attached to the vehicle's
27 windshield.

28 II. In the case of a vessel, be attached adjacent to the
29 vessel registration number on the left or port side of the
30 vessel.

31 III. Be at least 8 inches by 10 inches in size and be
32 sufficiently weatherproofed to withstand normal exposure to the
33 elements.

34 IV. Clearly indicate the date on which the notice is
35 posted.

36 V. Clearly indicate in bold letters that the vehicle or
37 vessel will be towed or removed from the real property 5 days
38 after the date on which a local law enforcement agency verifies
39 and documents with a police report the notice's compliance with
40 s. 715.07(2) (a) 6.

41 VI. Provide the name and phone number of the proposed
42 towing company.

43 b. The local law enforcement agency is notified of the
44 notice being posted pursuant to this subparagraph, and the local
45 law enforcement agency verifies and documents the notice's
46 compliance with this subparagraph with a police report that
47 shall be provided to the property owner and the towing company.
