17	Section 1. (1) The Florida Mission Readiness Commission
18	is created and shall be assigned to the Department of Health for

21	adults to grow up to meet the challenges of adulthood and
22	determine how that readiness is affected by physical fitness,
23	academic achievement, and character. The commission shall
24	recommend to the legislative, executive, and judicial branches
25	of state government public policy initiatives that increase the
26	preparedness and readiness of the state's youth to enable them

54	(4) The commission shall elect a chair and vice chair at
55	its first meeting. The commission shall meet quarterly and at
56	the call of the chair. The first meeting shall be held no later
57	than March 1, 2015.
58	(5) The commission shall be funded annually by the
59	Legislature. Members of the commission shall serve without
60	compensation but are entitled to reimbursement for per diem and
61	travel expenses incurred in the performance of their duties as
62	provided in s. 112.061, Florida Statutes.
63	(6) The commission shall issue a preliminary annual report
64	during the first and second years of its existence and a final
65	report no later than March 1, 2018, to the Cabinet, the
