4 Between lines 111 and 112, insert:

5 Section 2. Paragraphs (m) and (n) are added to subsection  
6 (5) of section 287.0571, Florida Statutes, to read:

7 287.0571 Business case to outsource; applicability.-

8 (5) In addition to the contract requirements provided in  
9 s. 287.058, each contract for a proposed outsourcing, pursuant  
10 to this section, must include, but need not be limited to, the  
11 following contractual provisions:

12 (m) A provision that requires disclosure of the  
13 contractor's chief executive officer compensation and executive  
14 compensation packages.

15       (n) A provision that:

16       1. Prohibits the contractor from authorizing an automatic  
17 increase in the salary or benefits of an employee of the  
18 contractor if the employee is providing an activity or service  
19 under the contract.

20       2. Requires the contractor to submit a written request to  
21 the agency for approval of an increase in the salary or benefits  
22 of an employee described in subparagraph 1.

23       3. Requires the agency, if the agency approves any  
24 increase in salary or benefits pursuant to subparagraph 2., to  
25 inform the contractor of the reasons that justify approval of  
26 the increase, including the employee's original base salary and  
27 the percentage of the approved increase.

28  
29 By July 1 of each year, beginning in 2015, the Office of Program  
30 Policy Analysis and Government Accountability shall submit a  
31 report to the President of the Senate and the Speaker of the  
32 House of Representatives that contains the total number of  
33 requests by contractors pursuant to this paragraph for increases  
34 in salaries or benefits of employees, the number of approved  
35 requests, the percentage increase of each approved request for a  
36 salary increase or a description of increased benefits for any  
37 approved request for a benefit increase, and the reasons for  
38 granting approval of the request.
