Remove everything after the enacting clause and insert: Section 1. Paragraph (a) of subsection (2) of section 627.711, Florida Statutes, is amended, and paragraph (c) is added to that subsection, to read:

627.711 Notice of premium discounts for hurricane loss mitigation; uniform mitigation verification inspection form.—

(2) (a) The Financial Services Commission shall develop by rule a uniform mitigation verification inspection form that shall be used by all insurers when submitted by policyholders for the purpose of factoring discounts for wind insurance. In developing the form, the commission shall seek input from insurance, construction, and building code representatives.

Further, the commission shall provide guidance as to the length of time the inspection results are valid. An insurer shall accept as valid a uniform mitigation verification <u>inspection</u> form signed by the following authorized mitigation inspectors:

- 1. A home inspector licensed under s. 468.8314 who has completed at least 3 hours of hurricane mitigation training approved by the Construction Industry Licensing Board which includes hurricane mitigation techniques and compliance with the uniform mitigation verification inspection form and completion of a proficiency exam;
 - 2. A building code inspector certified under s. 468.607;
- 3. A general, building, or residential contractor licensed under s. 489.111;
 - 4. A professional engineer licensed under s. 471.015;
 - 5. A professional architect licensed under s. 481.213; or
- 6. Any other individual or entity recognized by the insurer as possessing the necessary qualifications to properly complete a uniform mitigation verification inspection form.
- (c) An insurer issuing a policy to a new policyholder may accept as valid only the uniform mitigation verification inspection form:
 - 1. Most recently adopted by the commission by rule; or
- 2. Previously adopted by the commission by rule if the form was completed within 5 years preceding the effective date of the new policy.
 - Section 2. This act shall take effect July 1, 2015.
