Between lines 77 and 78, insert:

Section 3. Paragraph (a) of subsection (1) and subsection  
 (3) of section 373.467, Florida Statutes, are amended to read:

373.467 The Harris Chain of Lakes Restoration Council.—

There is created within the St. Johns River Water Management  
 District, with assistance from the Fish and Wildlife  
 Conservation Commission and the Lake County Water Authority, the  
 Harris Chain of Lakes Restoration Council.

(1) (a) The council shall consist of nine voting members,  
 which shall include: a representative of waterfront property  
 owners, a representative of the sport fishing industry, a person  
with experience in an environmental science or regulation

18 ~~engineer~~, a person with training in biology or another  
 19 scientific discipline, ~~a person with training as an attorney, a~~  
 20 ~~physician, a person with training as an engineer~~, and two  
 21 residents of the county who do not need meet any specific ~~of the~~  
 22 ~~other~~ qualifications for membership ~~enumerated in this~~  
 23 ~~paragraph~~, each to be appointed by the Lake County legislative  
 24 delegation. The Lake County legislative delegation may waive the  
 25 qualifications for membership on a case-by-case basis if good  
 26 cause is shown. ~~A~~ ~~Ne~~ person serving on the council may not be  
 27 appointed to a council, board, or commission of any council  
 28 advisory group agency. The council members shall serve as  
 29 advisors to the governing board of the St. Johns River Water  
 30 Management District. The council is subject to ~~the provisions of~~  
 31 chapters 119 and 120.

32 (3) The council shall meet at the call of its chair, at  
 33 the request of six of its members, or at the request of the  
 34 chair of the governing board of the St. Johns River Water  
 35 Management District. Resignation by a council member, or failure  
 36 by a council member to attend three consecutive meetings without  
 37 an excuse approved by the chair, shall result in a vacancy on  
 38 the council.
