by toll revenues collected on the Alligator Alley and the Sunshine Skyway Bridge, ~~the Beeline-East Expressway, the Navarre Bridge, and the Pinellas Bayway~~ to fund transportation projects located within the county or counties in which the project is located and contained in the adopted work program of the department.

11 (11) The department's Pinellas Bayway System may be
12 transferred by the department and become part of the turnpike
13 system under the Florida Turnpike Enterprise Law. The transfer
14 does not affect the rights of the parties, or their successors
15 in interest, under the settlement agreement and final judgment
16 in *Leonard Lee Ratner, Esther Ratner, and Leeco Gas and Oil Co.*
17 *v. State Road Department of the State of Florida*, No. 67-1081
18 (Fla. 2nd Cir. Ct. 1968). Upon transfer of the Pinellas Bayway
19 System to the turnpike system, the department shall also
20 transfer to the Florida Turnpike Enterprise the funds deposited
21 in the reserve account established by chapter 85-364, Laws of
22 Florida, as amended by chapters 95-382 and 2014-223, Laws of
23 Florida, which funds shall be used by the Florida Turnpike
24 Enterprise solely to help fund the costs of repair or
25 replacement of the transferred facilities.

26 Section 25. Chapter 85-364, Laws of Florida, as amended by
27 chapters 95-382 and 2014-223, Laws of Florida, is repealed.
