Section 43. Subsection (1) and paragraph (d) of subsection (3) of section 559.9285, Florida Statutes, are amended to read:

559.9285 Certification of business activities.—

(1) Each certifying party, as defined in s. 559.927(2):

(a) Which does not offer for sale, at wholesale or retail, prearranged travel ~~or~~ tourist-related services, ~~or tour-guide services~~ for individuals or groups directly to any terrorist

13 (b) Which offers for sale, at wholesale or retail, only

41 (2) Which violation directly or indirectly pertains to an
42 offer to sell, at wholesale or retail, prearranged travel or
43 tourist-related services, ~~or tour guide services~~ for individuals
44 or groups directly to any terrorist state and which originate in
45 Florida, commits a felony of the third degree, punishable as
46 provided in s. 775.082 or s. 775.083.

47 Section 45. For the 2016-2017 fiscal year, the sum of
48 \$1,305,097 in nonrecurring funds from the Division of Licensing
49 Trust Fund is appropriated to the Department of Agriculture and
50 Consumer Services for the purpose of implementing s. 493.6108,
51 Florida Statutes, regarding the collection and subsequent
52 payment of fingerprint retention and processing fees to the
53 Florida Department of Law Enforcement.

54 Section 46. Except as otherwise expressly provided in this
55 act and except for this section, which shall take effect upon
56 becoming law, this act shall take effect July 1, 2016.
