A bill to be entitled

An act relating to the Downtown Development Authority
of the City of Fort Lauderdale, Broward County;
amending chapter 2005-346, Laws of Florida; expanding
boundaries of the authority; requiring a referendum;
providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 35 is added to section 3 of chapter 2005-346, Laws of Florida, to read:

Section 35. There shall be added to and included with the boundaries of the downtown as defined by this act, specifically excluding each residential unit for which a homestead exemption is in effect as of January 1 of the applicable year, the following lands in the City of Fort Lauderdale, Broward County, Florida, to wit:

Beginning at a point on the west right-of-way line of
Federal Highway and the south right-of-way line of
State Road 84; thence westerly on said south right-ofway line of State Road 84 to the west right-of-way
line of the Florida East Coast Railroad; thence
northerly on said west right-of-way line to the
easterly extension of the centerline of SW 19th

Section 2. This act shall take effect only upon the majority vote of those qualified electors residing within the area described in section 1, voting in a referendum to be held in conjunction with the next general election held in Broward County, except that this section shall take effect upon becoming a law.
