The Committee on Education (Broxson) recommended the following: Senate Amendment (with title amendment) Delete lines 150 - 191 and insert: (PSAT/NMSQT), or the <u>PreACT Act Aspire</u> to all enrolled 10th grade students. However, a written notice shall be provided to each parent <u>which must</u> that shall include the opportunity to exempt his or her child from taking the PSAT/NMSQT or <u>the PreACT</u> <u>ACT Aspire</u>. (a) Test results will provide each high school with a database of student assessment data which certified school

(6) The partnership shall:

(j) Provide information to students, parents, teachers, counselors, administrators, districts, Florida College System institutions, and state universities regarding PSAT/NMSQT or <u>the</u> <u>PreACT</u> ACT Aspire administration, including but not limited to:

1. Test administration dates and times.

2. That participation in the PSAT/NMSQT or the PreACT $\overline{\text{ACT}}$ ASPIRE is open to all 10th grade students.

3. The value of such tests in providing diagnostic feedback on student skills.

4. The value of student scores in predicting the probability of success on AP or other advanced course examinations.

(8) (a) By September 30 of each year, the partnership shall submit to the department a report that contains an evolution of the effectiveness of the delivered services and activities. Activities and services must be evaluated on their effectiveness at raising student achievement and increasing the number of AP or other advanced course examinations in low-performing middle and high schools.
