**Amendment (with title amendment)**

Remove everything after the enacting clause and insert:

Section 1. Paragraph (ffff) is added to subsection (4) of section 320.08056, Florida Statutes, to read:

320.08056 Specialty license plates.—

(4) The following license plate annual use fees shall be collected for the appropriate specialty license plates:

(ffff) American Eagle license plate, \$25.

Section 2. Paragraph (b) of subsection (80) of section 320.08058, Florida Statutes, is amended and subsection (84) is created to read:

320.08058 Specialty license plates.—

## 17 (80) FALLEN LAW ENFORCEMENT OFFICERS LICENSE PLATES.—

18 (b) The annual use fees shall be distributed to the Police  
19 and Kids Foundation, Inc., which may use up to a maximum of 10  
20 percent of the proceeds for marketing to promote and market the  
21 plate. All remaining proceeds shall be distributed to and used  
22 by the Police and Kids Foundation, Inc., for its operations,  
23 activities, programs, and projects ~~The remainder of the proceeds~~  
24 ~~shall be used by the Police and Kids Foundation, Inc., to invest~~  
25 ~~and reinvest, and the interest earnings shall be used for the~~  
26 ~~operation of the Police and Kids Foundation, Inc.~~

27 (84) AMERICAN EAGLE LICENSE PLATES.—

28 (a) The department shall develop an American Eagle license  
29 plate as provided in this section and s. 320.08053. The plate  
30 must bear the colors and design approved by the department. The  
31 word "Florida" must appear at the top of the plate, and the  
32 words "God Bless America" must appear at the bottom of the  
33 plate.

34 (b) The annual use fees from the sale of the plate shall  
35 be distributed to the American Eagle Foundation for deposit in  
36 the foundation's national endowment fund. The American Eagle  
37 Foundation shall use the proceeds to fund public education  
38 programs, rescue and care programs, and other conservation  
39 efforts in Florida that benefit bald eagles.

40 Section 3. This act shall take effect October 1, 2017.
