Section 37. Section 322.161, Florida Statutes, is amended to read:

322.161 High-risk drivers; restricted licenses.-

(1) This section may be cited as the "Brittany Baxter Act."

(2)~~(1)~~(a) Notwithstanding any provision of law to the contrary, the department shall restrict the driving privilege of any Class E licensee who is age 15 through 17 and who has accumulated six or more points pursuant to s. 318.14, excluding

14 parking violations, within a 15-month ~~12-month~~ period.

15 (b) Upon determination that any person has accumulated six
16 or more points, the department shall notify the licensee and
17 issue the licensee a restricted license for business purposes
18 only. The licensee must appear before the department within 10
19 days after notification to have this restriction applied. The
20 period of restriction shall be for at least ~~a period of no less~~
21 ~~than~~ 1 year beginning on the date it is applied by the
22 department. During the period of restriction, the licensee must
23 complete a 12-hour approved advanced driver improvement course
24 and receive 4 hours of behind-the-wheel training from a Florida
25 licensed commercial driving school. Successful completion of a
26 behind-the-wheel examination is required in order to receive
27 completion credit for the course.

28 (c) The restriction shall be automatically withdrawn by
29 the department after 1 year if the licensee has completed such
30 driver improvement course approved by the department and does
31 not accumulate any additional points. If the licensee has not
32 completed the course requirement, the period of restriction
33 shall be extended until such time as the licensee completes the
34 course requirement. If the licensee accumulates any additional
35 points, then the period of restriction shall be extended 90 days
36 for each point. The restriction shall also be automatically
37 withdrawn upon the licensee's 18th birthday if no other grounds
38 for restriction exist. The licensee must appear before the
