A bill to be entitled

An act relating to Gadsden County; authorizing a referendum for the authorization of slot machine gaming at a pari-mutuel quarter horse facility in the City of Gretna; allowing a favorable referendum to qualify a facility as an eligible facility for the purposes of slot machine gaming; providing an effective date.

WHEREAS, the Legislature has provided in s. 551.102(4), Florida Statutes, that any licensed pari-mutuel facility in a county in which "a majority of voters have approved slot machines at such facilities in a countywide referendum held pursuant to a statutory or constitutional authorization after the effective date of this section in the respective county" is eligible for slot machine gaming, and

WHEREAS, Gadsden County previously conducted a favorable slot machine referendum in 2012 regarding slot machine gaming, and

WHEREAS, the Florida Supreme Court in Gretna Racing, LLC v. Florida Department of Business and Professional Regulation concluded that the Legislature did not specifically authorize the conduct of the referendum, and

WHEREAS, Gadsden County is a county with unique economic development challenges, and

26 WHEREAS, Gadsden County is uniquely positioned in North 27 Florida to take advantage of the economic development that could 28 result from slot machine gaming and development in and around 29 the interstate exit located within the City of Gretna near the 30 pari-mutuel quarter horse facility, and 31 WHEREAS, the Legislature acknowledges these unique factors 32 in granting Gadsden County the right to move forward with a slot 33 machine gaming referendum, NOW, THEREFORE, 34 35 Be It Enacted by the Legislature of the State of Florida: 36 37 The purpose of this act is to provide to 38 Gadsden County specific statutory authorization to act on the 39 subject of slot machine gaming under s. 551.102(4), Florida 40 Statutes. 41 Section 2.
