26 The supervisor shall enter into an agreement with the (a) 27 local clerk of the circuit court to receive monthly from such 28 clerk change-of-address information and a list of potential 29 jurors who identified themselves as aliens, as defined in s. 327.02(2), during the preceding calendar month. Each list shall 30 31 include the name, address, date of birth, sex, and, whichever is 32 available, the Florida driver license number or Florida 33 identification card number of each such person. The supervisor 34 shall compare all of the information included in the list each 35 month with the statewide voter registration system. Section 2.
