



1                   A bill to be entitled  
2           An act relating to transportation facility  
3           designations; providing honorary designation of  
4           various transportation facilities in specified  
5           counties; directing the Department of Transportation  
6           to erect suitable markers; providing an effective  
7           date.

9   Be It Enacted by the Legislature of the State of Florida:

10  
11           Section 1. Transportation facility designations;  
12 Department of Transportation to erect suitable markers.—

13           (1) That portion of S.R. 4 between Munson Highway and S.R.  
14 189 in Santa Rosa and Okaloosa Counties is designated as  
15 "Senator Greg Evers Memorial Highway."

16           (2) That portion of U.S. 90/S.R. 10 between S.R. 285 and  
17 N. 9th Street/S.R. 83 N. in Walton County is designated as  
18 "Lieutenant Ewart T. Sconiers Highway."

19           (3) That portion of S.R. 9336/S.W. 344th Street/W. Palm  
20 Drive between S.W. 192nd Avenue/Tower Road and S.W. 177th  
21 Avenue/S. Krome Avenue in Miami-Dade County is designated as  
22 "Steve Mainster Memorial Drive."

23           (4) That portion of I-595 between S.W. 136th Avenue and  
24 S.R. 823/Flamingo Road in Broward County is designated as  
25 "Deputy Ryan Seguin Memorial Highway."



26       (5) The interchange on S.R. 91/the Florida Turnpike at  
27 mile marker 279 in Lake County is designated as "Tera Ross  
28 Memorial Interchange."

29       (6) Upon completion of construction, the pedestrian bridge  
30 over S.R. 390 at Kentucky Avenue and Mowat School Road in Bay  
31 County is designated as "Harold Haynes Memorial Pedestrian  
32 Bridge."

33       (7) That portion of S.R. 109/University Boulevard between  
34 Clifton Avenue and Fort Caroline Road in Duval County is  
35 designated as "Jim Tullis Memorial Boulevard."

36       (8) That portion of S.R. 46 between International Parkway  
37 and S.R. 431/Orange Boulevard in Seminole County is designated  
38 as "Dr. R.C. Sproul Way."

39       (9) That portion of S.R. 190/Valparaiso Parkway between  
40 S.R. 85/Government Avenue and S.R. 397/John Sims Parkway in  
41 Okaloosa County is designated as "John B. Arnold, Jr., Memorial  
42 Highway."

43       (10) Bridge number 570018 on S.R. 85/Eglin Parkway over  
44 Garnier Bayou in Okaloosa County is designated as "Deputies Tony  
45 Forgione and Bill Myers Memorial Bridge."

46       (11) That portion of S.R. 85 between College Boulevard and  
47 Colonel Greg Malloy Road in Okaloosa County is designated as  
48 "SFC William Kelly Lacey Memorial Highway."

49       (12) That portion of S.R. 414/Maitland Boulevard between  
50 Magnolia Homes Road and S.R. 434/Forest City Road in Seminole



51 County is designated as "Deputy Matt Miller Memorial Boulevard."

52 (13) That portion of Peninsula Corp Drive between I-  
53 95/S.R. 9 and Congress Avenue in Palm Beach County is designated  
54 as "Richard Jason Randolph Memorial Bridge."

55 (14) That portion of U.S. 90/S.R. 10 between Chaires Cross  
56 Road and S.R. 59/Gamble Road in Leon and Jefferson Counties is  
57 designated as "Deputy Christopher Smith Memorial Highway."

58 (15) That portion of S.R. 464/Maricamp Road between S.E.  
59 25th Avenue and S.E. 24th Street in Marion County is designated  
60 as "Nelle W. Needham Memorial Highway."

61 (16) Bridge numbers 150202 and 150203 on S.R. 580/Main  
62 Street in Pinellas County are designated as "Gold Star Family  
63 Memorial Bridge, dedicated to U.S. Army CPL Frank R. Gross."

64 (17) That portion of U.S. 17-92 between Wisconsin Avenue  
65 and Saxon Boulevard in Volusia County is designated as "Amos  
66 Walter Atchley Memorial Highway."

67 (18) That portion of S.R. 415 between Acorn Lake Road and  
68 Reed Ellis Road in Volusia County is designated as "David G.  
69 Ledgerwood Memorial Highway."

70 (19) That portion of E. 9th Avenue between N. 13th Street  
71 and N. 14th Street in Hillsborough County is designated as "Nick  
72 Capitano Memorial Road."

73 (20) That portion of C.R. 574/7th Avenue between N. 20th  
74 Street and 22nd Street in Hillsborough County is designated as  
75 "Gonzmart Memorial Road."



76        (21) That portion of S.R. 583/56th Street between S.R.  
77 574/E. Dr. Martin Luther King, Jr., Boulevard and Harney Road in  
78 Hillsborough County is designated as "Pepin Memorial Road."

79        (22) That portion of Port Avenue between McCloskey  
80 Boulevard and Shoreline Avenue in Hillsborough County is  
81 designated as "Barkett Memorial Road."

82        (23) That portion of N. MacDill Avenue between W. Woodlawn  
83 Avenue and S.R. 574 in Hillsborough County is designated as "Jim  
84 Holmes Memorial Road."

85        (24) That portion of the San Juan Street Extension in  
86 Anastasia State Park between Santander Street and Anastasia Park  
87 Road in St. Johns County is designated as "Nona and Popa Road."

88        (25) That portion of U.S. 90 between Main Avenue and  
89 Martin Luther King, Jr., Avenue in Jefferson County is  
90 designated as "Lance Corporal Clemon 'Clyde' Alexander Memorial  
91 Drive."

92        (26) That portion of S.R. 115/Southside Boulevard between  
93 Geiger Road and Leahy Road in Duval County is designated as  
94 "Benolken Parkway."

95        (27) That portion of U.S. 90 between the Shoal River  
96 Bridge and the Walton County line in Okaloosa County is  
97 designated as "Deputies Skip York and Burt Lopez Memorial  
98 Highway."

99        (28) That portion of S.R. 19 between Lane Park Cutoff Road  
100 and U.S. 441 in Lake County is designated as "Sheriff Chris



101 Daniels Memorial Highway."

102 (29) That portion of E. 4th Avenue between E. 21st Street  
103 and E. 32nd Street in Miami-Dade County is designated as "John  
104 J. Brunetti, Sr., Avenue."

105 (30) That portion of I-75/S.R. 93 between mile marker 110  
106 and the Broward County line in Collier County is designated as  
107 "Submarine Veterans Memorial Highway."

108 (31) That portion of I-75/Alligator Alley between mile  
109 marker 24 and mile marker 26 in Broward County is designated as  
110 "Trooper Stephen G. Rouse Memorial Highway."

111 (32) The pedestrian bridge over S.R. 436/Semorán Boulevard  
112 (75003000) at Abercorn Drive in Orange County is designated as  
113 "Elias 'Rico' Piccard Memorial Overpass."

114 (33) Bridge number 105503 on W. Laurel Street over the  
115 Hillsborough River in Hillsborough County is designated as  
116 "Fortune Taylor Bridge."

117 (34) That portion of 5th Street between Euclid Avenue and  
118 Lenox Avenue in Miami-Dade County is designated as "Joseph  
119 Emmanuel 'Manno' Charlemagne Street."

120 (35) The Department of Transportation is directed to erect  
121 suitable markers designating the transportation facilities as  
122 described in this section.

123 Section 2. This act shall take effect July 1, 2018.
