32 775.083, or s. 775.084. However, a person who falsely personates
33 any such officer during the course of the commission of a felony
34 commits a felony of the second degree, punishable as provided in
35 s. 775.082, s. 775.083, or s. 775.084. If the commission of the
36 felony results in the death or personal injury of another human
37 being, the person commits a felony of the first degree,
38 punishable as provided in s. 775.082, s. 775.083, or s. 775.084.
39 The term "watchman" means a security officer licensed under
40 chapter 493.
