The program shall 27 provide funds to participating historically black colleges and 28 universities in the state to provide scholarships to students 29 enrolled at the schools. 30 The Legislature shall appropriate \$2 million to be (2) 31 transferred to the Historically Black Colleges and Universities 32 Matching Endowment Scholarship Trust Fund for the program. No 33 later than June 30, 2020, each historically black college and 34 university in the state that wishes to participate in the program shall provide \$500,000 in matching funds. All funds 35 36 transferred to the trust fund for the program shall be invested 37 in accordance with the provisions of chapter 215. 38 Notwithstanding the provisions of s. 216.301 and pursuant to s. 39 216.351, the appropriated funds and all matching funds shall remain in the trust fund and the interest from such funds shall 40 41 be used for scholarships for students enrolled at participating 42 colleges and universities. 43 (3) Annually, the interest accumulated in the trust fund 44 for the program shall be equally allocated by the Department of 45 Education to each participating college and university to award 46 scholarships.
