7 Section 10. Subsection (4) of section 83.806, Florida
8 Statutes, is amended to read:

9 83.806 Enforcement of lien.—An owner's lien as provided in
10 s. 83.805 may be satisfied as follows:

11 (4) After the expiration of the time given in the notice,
12 an advertisement of the sale or other disposition shall be
13 published once a week for 2 consecutive weeks in a newspaper of
14 general circulation in the area where the self-service storage
15 facility or self-contained storage unit is located or published

16 continuously for 14 consecutive days on a public website that
17 customarily conducts personal property auctions.

18 (a) A lien sale may be conducted on a public website that
19 customarily conducts personal property auctions. The facility or
20 unit owner is not required to hold a license to post property
21 for online sale. Inasmuch as any sale may involve property of
22 more than one tenant, a single advertisement may be used to
23 dispose of property at any one sale.

24 (b) The advertisement shall include:

25 1. A brief and general description of what is believed to
26 constitute the personal property contained in the storage unit,
27 as provided in paragraph (2) (b).

28 2. The address of the self-service storage facility or the
29 address where the self-contained storage unit is located and the
30 name of the tenant.

31 3. The time, place, and manner of the sale or other
32 disposition. The sale or other disposition shall take place at
33 least 15 days after the first publication.

34 ~~(c) If there is no newspaper of general circulation in the~~
35 ~~area where the self-service storage facility or self-contained~~
36 ~~storage unit is located, the advertisement shall be posted at~~
37 ~~least 10 days before the date of the sale or other disposition~~
