Section 2. Subsection (2) of section 44.106, Florida Statutes, as amended by SB 656, 2019 Regular Session, is amended to read:

44.106 Standards and procedures for mediators and arbitrators; fees.-

(2) An applicant for certification as a mediator shall undergo security background investigations, which include, but need not be limited to, the submission of a full set of fingerprints to the Department of Law Enforcement or to a vendor, entity, or agency authorized under s. 943.053(13). The vendor, entity, or agency shall forward the fingerprints to the Department of Law Enforcement for state processing and the Department of Law Enforcement shall forward the fingerprints to the Federal Bureau of Investigation for national processing. Fees for vendor, state, and federal fingerprint processing must be borne by the applicant. The cost for fingerprint processing is as provided in s. 943.053(3)(e) for records provided to persons or entities other than those specified as exceptions therein.

Section 3. This act shall take effect on the same date that SB 656 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law.
