## Amendment (with title amendment)

Remove everything after the enacting clause and insert: Section 1. Paragraph (a) of subsection (4) of section 493.6303, Florida Statutes, is amended to read:

493.6303 License requirements.—In addition to the license requirements set forth elsewhere in this chapter, each individual or agency must comply with the following additional requirements:

(4)(a) An applicant for a Class "D" license must submit proof of successful completion of a minimum of 40 hours of professional training at a school or training facility licensed by the department. Such training may be conducted by in-person instruction or online through a secure website of the school or

facility, provided that the applicant's identity, attendance, and successful completion of training are verified, and such verification is provided to the department upon completion of the training. The department shall by rule, and in accordance with s. 493.6103, establish the general content, and number of hours of each subject area to be taught, the method of delivery and the security protocols for online training and testing, the reporting requirements for verification of successful completion of training, and any other rules necessary for the regulation of schools providing in-person or online training.

Section 2. Paragraphs (a) and (b) of subsection (2) of section 493.6304, Florida Statutes, are amended to read:

493.6304 Security officer school or training facility.-

- (2) The application shall be signed and verified by the applicant under oath as provided in s. 92.525 and must contain, at a minimum, the following information:
- (a) The name and address of the school or training facility, or, if the training is conducted online, the name and website address of the school or facility, and, if the applicant is an individual, her or his name, address, and social security or alien registration number.
- (b) The street address  $\underline{\text{or website address}}$  of the place at which the training is to be conducted.

Section 3. This act shall take effect July 1, 2019.
