 2           An act relating to Holmes, Jackson, and Washington  
 3           Counties; amending ch. 69-534, Laws of Florida;  
 4           authorizing a Board of Directors to govern the  
 5           authority; providing for terms of office and  
 6           appointment of members to the board; providing and  
 7           revising organizational meeting dates; providing for  
 8           quorum and voting; revising certain officer positions  
 9           of the authority; providing an effective date.

 11 Be It Enacted by the Legislature of the State of Florida:

12  
 13           Section 1. Sections 1, 3, 4, and 5 of chapter 69-534, Laws  
 14 of Florida, are amended to read:

15           Section 1. There is hereby created the "Tri-County Airport  
 16 Authority," a body corporate, as an agency designed to  
 17 accomplish the cooperative joint effort of the boards of county  
 18 commissioners of Holmes County, Jackson County, and Washington  
 19 County, in the establishment and operation of an airport in  
 20 Holmes County near the common geographic boundary point of said  
 21 counties.

22           Section 3. The authority ~~hereby created~~ shall be governed  
 23 by a Board of Directors (board) consisting ~~consist~~ of nine (9)  
 24 ~~fifteen (15) members, of which number five (5) shall be~~  
 25 ~~appointed by the board of county commissioners of each of the~~

26 | ~~three (3) participating counties of Holmes, Jackson and~~  
 27 | ~~Washington, initial appointments to be made not later than~~  
 28 | ~~thirty (30) days after July 1, 1969. Three (3) members shall be~~  
 29 | ~~appointed by the Holmes County Board of County Commissioners,~~  
 30 | ~~three (3) members shall be appointed by the Jackson County Board~~  
 31 | ~~of County Commissioners, and three (3) members shall be~~  
 32 | ~~appointed by the Washington County Board of County~~  
 33 | ~~Commissioners. Within sixty (60) days after the effective date~~  
 34 | ~~of this act, each county board of county commissioners shall~~  
 35 | ~~appoint members for initial terms to begin on the date that the~~  
 36 | ~~organizational meeting is held pursuant to section 4. On that~~  
 37 | ~~same date, all terms of the members of the board existing on~~  
 38 | ~~July 1, 2020, shall terminate; however, such members may~~  
 39 | ~~continue to serve additional terms if reappointed by the Holmes,~~  
 40 | ~~Jackson, or Washington County Board of County Commissioners. For~~  
 41 | ~~the purpose of providing staggered terms, each county board of~~  
 42 | ~~county commissioners shall appoint one (1) member to serve an~~  
 43 | ~~initial term ending on October 1, 2021, one (1) member to serve~~  
 44 | ~~an initial term ending on October 1, 2022, and one (1) member to~~  
 45 | ~~serve an initial term ending on October 1, 2023. ~~Members of the~~~~  
 46 | ~~~~original authority shall be appointed for terms as follows from~~~~  
 47 | ~~~~each of the three (3) participating counties: One (1) member for~~~~  
 48 | ~~~~a one (1) year term ending July 1, 1970; one (1) member for a~~~~  
 49 | ~~~~two (2) year term ending July 1, 1971; one (1) member for a~~~~  
 50 | ~~~~three (3) year term ending July 1, 1972; one (1) member for a~~~~

51 ~~four (4) year term ending July 1, 1973; and one (1) member for a~~  
52 ~~five (5) year term ending July 1, 1974; and Thereafter,~~ members  
53 shall be appointed to the board for three (3) year terms, except  
54 appointments to fill vacancies for unexpired terms, in which  
55 event the appointment shall be for the unexpired term only. The  
56 members of the board ~~authority~~ shall receive no compensation for  
57 their services but shall be entitled to reimbursement ~~be~~  
58 ~~reimbursed~~ for per diem and travel expenses incurred in the  
59 performance of their official duties ~~as members of the authority~~  
60 when authorized by the board ~~a majority of the members of the~~  
61 ~~authority at a regular meeting,~~ subject to the applicable  
62 provisions and limitations of section 112.061, Florida Statutes.

63 Section 4. Not later than thirty (30) ~~fifteen (15)~~ days  
64 after the appointment of members to initial terms pursuant to  
65 section 3 ~~the authority created hereby,~~ and annually thereafter  
66 during October ~~July~~ of each year, the members of the board shall  
67 hold an organizational meeting at which they shall elect from  
68 their own membership a chairman, a vice-chairman, ~~and a~~  
69 secretary ~~secretary-treasurer,~~ and a treasurer. Except as  
70 otherwise provided by law, no business shall be transacted by  
71 the authority except at a public ~~regular-called~~ meeting of the  
72 Board of Directors ~~members,~~ at which a quorum is present and the  
73 minutes thereof recorded. A majority of the members of the board  
74 shall constitute a quorum, and the affirmative vote of a  
75 majority of the members present shall be necessary for any

76 | action taken by the board. Permanent records shall be maintained  
77 | which shall reflect all official actions of the authority  
78 | including all financial transactions.

79 |       Section 5. The treasurer ~~secretary-treasurer~~ of the  
80 | authority ~~hereby created~~ shall give bond payable to the governor  
81 | of the state in such amount and under such conditions as may be  
82 | determined by the members of the authority.

83 |       Section 2. This act shall take effect July 1, 2020.
