Section 1. Subsection (8) of section 322.08, Florida
Statutes, is amended to read:

322.08 Application for license; requirements for license
and identification card forms.—

(8) The application form for an original, renewal, or
replacement driver license or identification card must include

46 Child Sexual Abuse, which shall be distributed to Lauren's Kids,
47 Inc., a nonprofit organization.

48 (m) A voluntary contribution of \$1 per applicant, which
49 shall be distributed to Prevent Blindness Florida, a not-for-
50 profit organization, to prevent blindness and preserve the sight
51 of the residents of this state.

52 (n) Notwithstanding s. 322.081, a voluntary contribution of
