21	(1) Beginning with the 2022 primary election and each
22	election thereafter, an electronic poll book may not be used as
23	a precinct register unless it is approved for such use by the
24	department.
25	(2) The department shall adopt rules for the approval of an
26	electronic poll book which provide that the electronic poll
27	book, at a minimum, must:
28	(a) Be secure from unauthorized intrusion.

37	Section 2. Risk-limiting audit pilot program
38	(1) As used in this section, the term "risk-limiting audit"
39	means an audit protocol that makes use of statistical methods to
40	manually check a sample of ballots or voter-verifiable paper
41	output from a voter interface device and is designed to limit to
42	acceptable levels the risk of certifying a preliminary election
43	outcome that constitutes an incorrect outcome.
44	(2) The Department of State shall conduct a pilot program
45	for the 2020 general election to assess the effectiveness of
46	risk-limiting audits as opposed to the post-election auditing
47	methods provided under existing law. In consultation with the
48	Florida State Association of Supervisors of Elections, the
49	department shall designate at least five but not more than seven
50	counties for participation in the pilot program. To the extent
51	possible, the department shall endeavor to select counties of
52	varying sizes that use various voting systems for participation
53	in the pilot program. Participation by a county in the pilot
54	program is voluntary.
55	(3) A county that participates in the pilot program shall
56	conduct a public risk-limiting audit following completion of the
57	voting system audit required under s. 101.591, Florida Statutes.
58	Within 15 days after completion of the risk-limiting audit, the

59	supervisor of elections of a participating county shall submit a
60	report to the Department of State detailing the results of the
61	risk-limiting audit and the procedures and methods followed in
62	conducting the audit.
63	(4) By October 1, 2021, the Department of State shall
64	submit a report detailing the results of the pilot program to
65	the Governor, the President of the Senate, the Speaker of the
66	House of Representatives, and the chairs of the legislative
67	committees having jurisdiction over election law. Additionally,
68	the report must address the effectiveness and efficiency of the
69	risk-limiting audit as compared with the audits conducted in the
70	same election pursuant to s. 101.591, Florida Statutes.
71	Section 3. This act shall take effect July 1, 2020.
