Section 5. It is the intent of the amendment to s.

316.008, Florida Statutes, made by this act to provide uniform private property rights laws in this state; to declare all ordinances and regulations null and void that have been enacted by any jurisdiction, other than state or federal government, which regulate fines imposed by private property owners of parking lots; and to prohibit the enactment of any future ordinances or regulations relating to the imposition of such fines.
