19	administration of a census outreach strategy to encourage the
20	full participation of this state's residents in the 2020 federal
21	decennial census of population required by 13 U.S.C. s. 141.
22	Except as otherwise provided in this section, the committee
23	shall operate in a manner consistent with s. 20.052, Florida
24	Statutes.
25	(2) The committee is composed of the following members:
26	(a) The President of the Senate, or his or her designee.
27	(b) The Speaker of the House of Representatives, or his or
28	her designee.
29	(c) The Minority Leader of the Senate, or his or her

64	(4) In developing a recommended census outreach strategy,
65	the committee shall consider, but is not limited to, the
66	following:
67	(a) State agency initiatives to encourage participation in

90	(b) Each state agency shall designate a census coordinator
91	who shall cooperate and provide support to the committee as
92	needed. Each state agency shall inform the department of its
93	designated census coordinator.
94	(c) For purposes of this subsection, the term "state
95	agency" means any agency or department under the jurisdiction of
96	the Governor, a Cabinet officer, or the Governor and Cabinet.
97	Any other entities of state government, including the
98	legislative and judicial branches, and units of local government
99	shall cooperate and provide assistance or information to the
100	committee upon request.
101	(7) The committee shall submit a report to the Governor,
102	the President of the Senate, and the Speaker of the House of
103	Representatives by June 30, 2020, which contains its
