limits the number of times that a parcel owner may rent his or her parcel during a specified term, applies only to a parcel owner who acquires title to the parcel after the effective date of the amendment, or to a parcel owner who consents, individually or through a representative, to the amendment.

- 2. Notwithstanding subparagraph 1., an association may amend its governing documents to prohibit or regulate rentals for a term of less than 6 months and to prohibit rentals more than three times in a calendar year, and such amendments shall apply to all parcel owners.
- 3. This paragraph does not affect the amendment restrictions for associations of 15 or fewer parcel owners under s. 720.303(1).
- 4. For purposes of this paragraph, a change of ownership does not occur when an affiliated entity acquires title from a parcel owner who is a natural person. For purposes of this subparagraph, the term "affiliated entity" means a business entity, including but not limited to a corporation, partnership, or limited partnership, controlled by the parcel owner or under the common control of the parcel owner. For a conveyance to be recognized as one made to an affiliated entity, the entity must furnish the association a document certifying that this paragraph applies, as well as providing any organizational documents for the parcel owner and the affiliated entity that
