5 homeowners' association, as defined in s. 723.075, with approval  
6 of its board of administration or directors, may file with the

9 the property appraiser determines are substantially similar with  
10 respect to location, proximity to amenities, number of rooms,  
11 living area, and condition. The condominium association,

15 hand delivery or certified mail, return receipt requested,  
16 except that such notice may be electronically transmitted to a  
17 unit owner or parcel owner who has expressly consented in  
18 writing to receiving such notices by electronic transmission. If  
19 the association is a condominium or cooperative association, the  
20 notice must also be posted conspicuously on the condominium or  
21 cooperative property in the same manner as notice of board  
22 meetings under ss. 718.112(2) and 719.106(1). Such notice must  
23 and shall provide at least 14 ~~20~~ days for a unit or parcel owner  
24 to elect, in writing, that his or her unit or parcel not be  
25 included in the petition.

26 2. A condominium association, as defined in s. 718.103, a  
27 cooperative association, as defined in s. 719.103, or a  
28 homeowners' association as defined in s. 723.075, that has filed  
29 a single joint petition under this subsection may continue to  
30 represent, prosecute, and defend the unit owners through any  
31 related subsequent proceeding in any tribunal, including  
32 judicial review under part II of this chapter and any appeals.  
33 This subparagraph is intended to clarify existing law and  
34 applies to cases pending on July 1, 2020.
