SUMMARY ANALYSIS

The National Collegiate Athletic Association (NCAA) is a nonprofit organization whose voluntary membership includes colleges, universities, athletic conferences, and other affiliated organizations. The NCAA regulates intercollegiate athletic competitions in various sports across multiple divisions. NCAA rules prohibit student-athletes from being paid for the use of their names, images, and likenesses.

CS/CS/HB 7051 authorizes intercollegiate athletes to earn compensation for their name, image, likeness, or persona (NILP). The bill seeks to preserve the integrity, quality, character, and amateur nature of intercollegiate athletics while maintaining a clear distinction between amateur and professional sports by:

- Providing that compensation for athletic performance or attendance at a particular institution remains prohibited.
- Prohibiting a postsecondary educational institution, an entity whose purpose includes supporting or benefitting the institution or its athletic programs, or an officer, director, or employee of such institution or entity from compensating or causing an intercollegiate athlete to be compensated for his or her NILP.

The bill prohibits postsecondary educational institutions receiving state aid (Florida College System institutions, State University System institutions, and private colleges and universities) from:

- Preventing or unduly restricting an intercollegiate athlete from earning NILP compensation.
- Preventing or unduly restricting an intercollegiate athlete from obtaining professional representation for purposes of seeking NILP compensation.
- Revoking or reducing grant-in-aid awards for an intercollegiate athlete who earns compensation for his or her NILP.

The bill specifies that the terms of a contract for NILP compensation may not materially conflict with the terms of the intercollegiate athlete's team contract or extend beyond the time of the athlete's participation in an athletic program at a postsecondary educational institution.

In addition, the bill requires each postsecondary educational institution receiving state aid to:

- Provide intercollegiate athletes with health and disability insurance, including the cost of deductibles, coinsurance, and copays and a death benefit of \$25,000.
- In the event of a sports-related injury, continue providing such insurance for the time it takes the athlete to recover from the injury, subject to certain conditions.
- Maintain grant-in-aid for intercollegiate athletes until the athlete graduates, under certain circumstances.
- Conduct a financial and life skills workshop at the beginning of the intercollegiate athlete's first and third academic years.

The bill will have an indeterminate fiscal impact on certain postsecondary educational institutions.

The bill provides an effective date of July 1, 2020.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. EFFECT OF PROPOSED CHANGES:

Background

National Collegiate Athletic Association

The National Collegiate Athletic Association (NCAA) is a nonprofit organization whose voluntary membership includes colleges, universities, athletic conferences, and other affiliated organizations. The NCAA regulates intercollegiate athletic competitions in various sports across three divisions (Division I, Division II, and Division III). As the governing body for the majority of intercollegiate athletic programs, the NCAA provides that its basic purpose is to “maintain intercollegiate athletics as an integral part of the educational program and the athlete as an integral part of the student body and, by so doing, retain a clear line of demarcation between intercollegiate athletics and professional sports.”¹

The NCAA issues and enforces rules governing athletic competitions among its member schools. The rules are developed by a member-led governance system in which members introduce and vote on proposed rules. The rules for student-athletes vary by division. In general, the NCAA's amateurism rules prohibit student-athletes from being paid for their athletic abilities, including being paid for commercial endorsements if the reason for being chosen for the commercial endorsement is because of the student's athletic ability. This prohibition includes compensation for the use of a student-athlete's name, image, and likeness in live games, telecast, videogames, and other footage.

Student-athletes are allowed to receive scholarships, or "grants-in-aid," which may cover tuition and fees, room and board, required course-related books, food, and cash stipends to help defray the actual cost of attending school. However, NCAA rules prohibit a student's grant-in-aid from exceeding the cost of attendance at their school.²

The NCAA, along with member colleges and universities, award nearly \$3.5 billion in athletic scholarships every year to more than 180,000 student-athletes. According to the NCAA, they also provide almost \$100 million each year to support student-athletes' academic pursuits and assist them with the basic needs of college life, such as a computer, clothing or emergency travel expenses.³

Florida Intercollegiate Athletic Programs

In Florida, 13 schools participate in NCAA Division I athletics, of which seven compete in the Football Bowl Subdivision, four compete in the Football Championship Subdivision, and two do not field football teams. There are 13 NCAA Division II athletic programs located in the state, and no NCAA Division III athletic programs. Additionally, Florida is home to 25 institutions participating in the National Junior College Athletic Association (NJCAA), 10 institutions participating in the National Association of Intercollegiate Athletics (NAIA), and three institutions participating in the National Christian College Athletic Association (NCCAA).

Florida Postsecondary Education System

There are various forms of financial assistance available to students in Florida’s postsecondary institutions.⁵ These include:⁶

- Gift Aid: A type of financial assistance that does not have to be paid back.
- Grant: A type of student financial assistance, usually based on financial need, designed to assist with educational costs and which has no repayment conditions.
- Loan: A type of student financial assistance that must be repaid.
- Scholarship: A type of student financial assistance based on specific criteria which does not have to be repaid.

Florida Statutes identify a number of publicly funded academic, need, and workforce based scholarships.⁷ However, athletic scholarships are not provided for in Florida Statutes. Individual schools award athletic scholarships and grants-in-aid to student athletes.⁸ This financial assistance may not exceed the cost of attendance.⁹ “Cost of attendance” is defined as the average cost for a student to attend a postsecondary institution for one academic year, which includes the cost of tuition and fees, books and supplies, room and board, transportation, and personal expenses.¹⁰ In Florida’s State University System, the average cost of attendance per semester in the 2019-20 school year was \$11,232.¹¹

NCAA Report on 2018 Division I Revenues and Expenses¹²

In 2018, over 1,100 NCAA schools spent more than \$18 billion on athletics while generating only \$10.3 billion in revenues. Of the total expenditures in 2018, \$3.5 billion went toward financial aid for student-athletes and \$3.4 billion was spent on coaches' compensation. In total, only 29 athletic departments had revenues that exceeded expenditures, all of them Power 5 schools¹³, with an average surplus of \$9.3 million. In 2018, Power 5 schools accounted for 73% of all NCAA revenues and 43% of total spending. As a whole, Division I schools accounted for 97% of all NCAA revenues and 83% of spending.

In 2018, median athletic expenses exceeded revenues by \$2.6 million at Power 5 schools, approximately \$22 million at non-Power 5 Division I schools, and \$13.3 million at Division I schools without football.¹⁴ Expenses exceeded revenues at every FCS institution as well.¹⁵ Schools subsidize athletic deficits with student activity fees, direct support from the university, and other means.

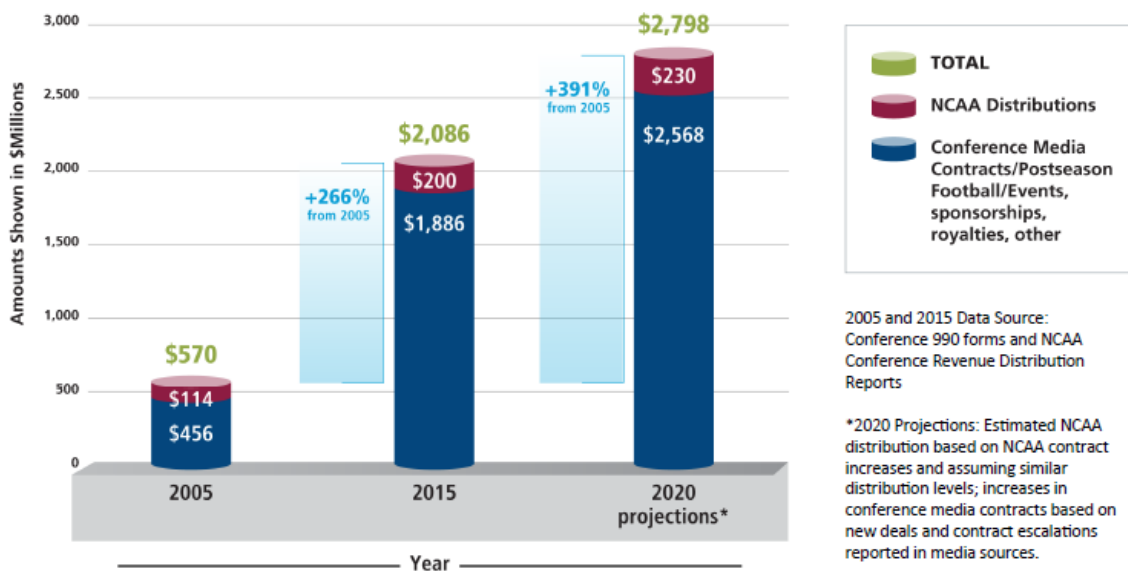

Amateurism

Notwithstanding the substantial revenues involved in intercollegiate athletics today, amateurism remains central to the NCAA model. The NCAA Constitution states:

The Principle of Amateurism. Student-athletes shall be amateurs in an intercollegiate sport, and their participation should be motivated primarily by education and by the physical, mental, and social benefits to be derived. Student participation in intercollegiate athletics is an avocation, and student-athletes should be protected from exploitation by professional and commercial enterprises.¹⁷

The NCAA Constitution further specifies that, relating to “amateur status,” an individual loses amateur status and is not eligible for intercollegiate competition in a particular sport if the individual:

- (a) Uses his or her athletics skill (directly or indirectly) for pay in any form in that sport;
- (b) Accepts a promise of pay even if such pay is to be received following completion of intercollegiate athletics participation;
- (c) Signs a contract or commitment of any kind to play professional athletics, regardless of its legal enforceability or any consideration received, except as permitted in Bylaw 12.2.5.1;
- (d) Receives, directly or indirectly, a salary, reimbursement of expenses or any other form of financial assistance from a professional sports organization based on athletics skill or participation, except as permitted by NCAA rules and regulations;
- (e) Competes on any professional athletics team per Bylaw 12.02.12, even if no pay or remuneration for expenses was received, except as permitted in Bylaw 12.2.3.2.1;
- (f) After initial full-time collegiate enrollment, enters into a professional draft (see Bylaw 12.2.4); or
- (g) Enters into an agreement with an agent.¹⁸

Notably, the NCAA lacks a clear or consistent definition for the term “amateurism.” Courts have observed that the NCAA’s definition is “malleable, changing frequently over time in significant and contradictory ways” and have even gone so far as to say that amateurism is not “a core principle of the NCAA.”¹⁹ Examples of permissible income under NCAA rules include:

- NCAA rules allow two-sport athletes to be paid professionals in one sport while competing in a different college sport, such as Kyle Parker’s \$1.4 million baseball signing bonus while serving as Clemson’s quarterback in 2010.
- University of Texas swimmer Joseph Schooling received a \$740,000 bonus from Singapore for winning a gold medal at the 2016 Olympics.
- Tennis players can receive up to \$10,000 per year in prize money (and additional cash on a per-event basis) before or during college.
- College football players can receive bowl gifts up to \$550 in value, which can involve players selecting high-tech electronics from a gift suite or receiving a Visa gift card.
- Schools have student-assistance funds to help athletes financially, including insurance policies for elite athletes who want to protect their professional futures.²⁰
- Student-athletes are permitted to accept Pell grants above and beyond their cost of attendance.²¹

However, a University of Central Florida football kicker was recently ruled ineligible by the NCAA because of the income that he receives from his monetized YouTube channel.²²

Name, Image, and Likeness

Individuals have a property right in their name, image, and likeness.²³ However, the NCAA prohibits student-athletes from being paid for the use of their names, images, and likenesses.²⁴ Many student-athletes generate significant value in their name, image, and likeness and could receive significant compensation for them in an open market.²⁵ In recent years, the NCAA’s policy of prohibiting student-athletes from receiving compensation for the use of their names, images, and likenesses has attracted legal challenges, which alleged that the NCAA’s prohibition is an unlawful restraint of trade and violates antitrust laws.

In general, federal and state antitrust laws are intended to promote and foster competition in the marketplace and prevent anticompetitive mergers and business practices. The NCAA and its member institutions have traditionally been viewed by the courts as different from professional leagues, and for this reason have been allowed to implement certain restrictions on competition that many argue are necessary for intercollegiate athletics to exist.²⁶

In *O’Bannon v. NCAA*, the U.S. Court of Appeals for the Ninth Circuit found that student-athletes may be injured as a result of the NCAA rules excluding athletes from the market for their names, images, and likenesses but concluded that the NCAA is only required to “permit its schools to provide up to the cost of attendance to their student athletes.”²⁷

Recent Developments

On September 11, 2019, the California Legislature passed SB 206, the “Fair Pay to Play Act”, the first law of its kind in the U.S. allowing college student-athletes to benefit financially from their name, image and likeness. This California law has an effective date of January 1, 2023.

On the same day, the NCAA Board of Governors responded, in part: “We urge the state of California to reconsider this harmful and, we believe, unconstitutional bill and hope the state will be a constructive partner in our efforts to develop a fair name, image and likeness approach for all 50 states.”²⁸ When SB 206 was signed into law a few weeks later, the NCAA released a statement which acknowledged the need for changes in its approach to the name, image, and likeness rights of its student-athletes.²⁹

On October 29, 2019, the NCAA’s top governing board voted unanimously to permit students participating in athletics the opportunity to benefit from the use of their name, image and likeness in a manner consistent with the collegiate model.³⁰ Specifically, the board stated that modernization should occur within the following principles and guidelines:

- Assure student-athletes are treated similarly to non-athlete students unless a compelling reason exists to differentiate.
- Maintain the priorities of education and the collegiate experience to provide opportunities for student-athlete success.
- Ensure rules are transparent, focused and enforceable and facilitate fair and balanced competition.
- Make clear the distinction between collegiate and professional opportunities.
- Make clear that compensation for athletic performance or participation is impermissible.
- Reaffirm that student-athletes are students first and not employees of the university.
- Enhance principles of diversity, inclusion, and gender equity.
- Protect the recruiting environment and prohibit inducements to select, remain at, or transfer to a specific institution.³¹

Athlete Agents

The licensing and regulation of athlete agents in Florida is a state government function administered by the Department of Business and Professional Regulation (DBPR). DBPR processes licenses and responds to consumer complaints and inquiries in addition to monitoring activities and compliance within the athlete agent industry.

An “athlete agent” is a person who:

- Directly or indirectly, recruits or solicits a student athlete to enter into an agent contract, or
- For any type of financial gain, procures, offers, promises, or attempts to obtain employment or promotional fees or benefits for a student athlete with a professional sports team or as a professional athlete, or
- With any promoter, markets or attempts to market the student athlete’s athletic ability or athletic reputation.³²

The term “athlete agent” includes all employees and other persons acting on behalf of an athlete agent who participate in the activities included under this subsection. The term does not include a spouse,

parent, sibling, grandparent, or guardian of the student athlete or an individual acting solely on behalf of a professional sports team or professional sports organization.

A “student athlete” is any student who:

- Resides in Florida and participates or formally intends to participate in a college or university’s intercollegiate athletics; or
- Does not reside in Florida, but participates or formally intends to participate in a Florida college or university’s intercollegiate athletics.³³

An “agent contract” is the contract or agreement in which a student athlete authorizes an athlete agent to represent the student in the marketing of the student’s athletic ability or athletic reputation.³⁴ In order to be valid, such contract is specifically required to include any fees paid to the agent and indicate how such fee is calculated. The athlete agent is also required to follow certain procedures during the contracting process, such as alerting the athletic director of the educational institution of the existence of the agent contract. The contracts are generally voidable by the student athlete within 14 days of execution.³⁵

In order to be licensed as an athlete agent, an applicant must be at least 18 years of age, of good moral character, and have completed the application form with fingerprints for a background check. Applicants must remit to DBPR an initial application fee of \$250, an initial licensure fee of \$375, an unlicensed activity fee of \$5, and a biennial renewal fee of \$220.³⁶

Athlete agents must establish and maintain complete business and financial records. The athlete agent is required to “save each entry into a financial or business record for at least 5 years from the date of entry.”³⁷ DBPR has the right to full inspection of such records and may exercise its subpoena powers to obtain the financial and business records of an athlete agent.

Athlete agents are subject to disciplinary action for violating practice requirements set forth in statute. Violations include:

- Commingling money or property of another person with the athlete agent’s money or property;³⁸
- Committing mismanagement or misconduct which causes financial harm to a student athlete or college or university;³⁹ and
- Violating or aiding and abetting another person to violate the rules of the athletic conference or collegiate athletic association governing a student athlete or student athlete’s college or university.⁴⁰

An unlicensed person is generally prohibited from acting as an athlete agent.⁴¹ Section 468.453(3), F.S., allows an unlicensed individual to act as an athlete agent if:

- A student athlete or person acting on the athlete’s behalf initiates communication with the individual; and
- Within seven days after an initial act as an athlete agent, the individual submits an application for licensure.

In Fiscal Year 2018-2019, there were 321 licensed athlete agents in Florida. DBPR received two complaints related to athlete agents, but did not take any disciplinary action.⁴²

Primary Basic Medical Insurance

The NCAA requires member institutions to certify that student-athletes in intercollegiate sports are insured for athletically related injuries⁴⁴ sustained while participating in “covered events.”⁴⁵ A “covered event” includes:

- Any intercollegiate sports activity, including team travel, competition, practices and conditioning sessions during the playing season;
- An NCAA-sanctioned competition in which the insured person is an official competitor; or
- Practice and conditioning sessions that are authorized, organized, or directly supervised by athletics department personnel at the member institution other than during the playing season. Such sessions must occur on campus or at approved off-campus facilities as part of an intercollegiate athletics activity. For insured student-athletes or prospective student-athletes who compete in individual sports, off-campus intercollegiate athletics activities must be authorized by athletics department personnel at the participating school and take place at approved locations.⁴⁶

The required insurance must be able to satisfy the deductible of the NCAA Catastrophic Injury Insurance Program.⁴⁷ The NCAA also requires that the institution provide medical coverage for at least two years following either graduation or separation of the student-athlete from the institution, whichever occurs first.⁴⁸ Compliant insurance may be provided by:

- Parents’ or guardians’ insurance coverage;
- The student-athlete’s personal insurance coverage; or
- The institution’s insurance program.

In the event that the student-athlete is uninsured or has insurance that does not meet the NCAA requirement, the NCAA sponsors two insurance products for coverage of the student-athlete. These products are voluntary and separately underwritten for each institution by the Mutual of Omaha insurance company.

The NCAA Group Basic Accident Medical Program is an insurance product sponsored by the NCAA for member institutions to secure group coverage of their student-athletes. This program is coordinated with the NCAA Catastrophic Injury Insurance Program to offer access to the NCAA’s catastrophic injury benefits at a lower deductible. The premium for the Group Basic program is paid by the member institution and the student-athlete participates as a member of the institution’s group. The NCAA also sponsors the NCAA Primary Accident Program for uninsured student-athletes whose institution does not provide a group insurance option for their student-athletes. Both the Group Basic and Primary Accident programs offer insurance plans that can be tailored to desired benefit and cost levels (i.e., minimum coverages, Health Maintenance Organizations, Preferred Provider Networks, varying deductibles and copays, selected sub-limits,⁴⁹ etc.). The premiums and costs vary depending on the details of the policy purchased.

NCAA Catastrophic Injury Insurance Program⁵⁰

The NCAA sponsors a catastrophic injury insurance program for active member institutions. This program is offered to member institutions at no additional cost. The insurance covers any student-athlete who is catastrophically injured while participating in a covered intercollegiate athletic activity. The policy has a \$90,000 deductible (\$75,000 for those institutions that participate in the NCAA Group Basic Accident Medical Program) and provides benefits in excess of any other valid and collectible insurance. Any student-athlete injury with medical expenses exceeding the applicable deductible will trigger the program's coverage.

The NCAA Catastrophic Injury Insurance Program covers students who are athletes, coaches, managers, trainers, and cheerleaders who are catastrophically injured in a covered event.⁵¹ This program provides a \$20 million maximum benefit with specified annual or service limits on selected benefit types. It provides various benefits, including medical, dental, rehabilitation, custodial care, disability (cash payments),⁵² and death⁵³ related to the covered catastrophic injury.

Coverage Behavior at NCAA Division I Institutions

In 2016, the NCAA reported on a survey it conducted of head athletic trainers at NCAA Division I institutions.⁵⁴ Seventy percent (232 institutions from 32 separate conferences) were reported to have responded to the survey. Notable findings include:

Insurance Coverage

- 68 percent of schools have a primary insurance requirement;
 - If the student-athlete was uninsured, 70 percent provided insurance to them;
- On average, more than 400 student-athletes were covered per institution, regardless of the method of coverage chosen by the institution;
- Methods of Coverage:
 - 67 percent purchase insurance;
 - 23 percent self-insure;
 - 6 percent require the student-athlete to obtain personal coverage; and
 - 4 percent make alternate financial arrangements.⁵⁵
- Insurance purchasers (about 155 institutions):
 - Nearly 60 percent had policy premiums between \$100,000 and \$500,000;
 - 45 percent had insurance deductibles between \$0.00 and \$1,000;
 - More than 75 percent provided a benefit period of 104 weeks; and
 - 87 percent of accidental insurance policies had no sub-limits;
- Self-insurers (about 53 institutions):
 - 72 percent stated student-athletes and families bear no costs;
 - 59 percent provided a benefit period of 104 weeks; and
 - 85 percent had no sub-limits.
- Student-athlete sourced personal coverage (about 14 institutions), these institutions:
 - Do not review the student-athlete's policies;
 - Provide guidance to the student-athlete regarding deductibles; and
 - Verify the student-athlete's personal coverage.

Costs for Injuries Not Covered by Insurance

- 84 percent covered 100 percent of the uninsured injury cost through the athletic program;
- Out of pocket costs to the institution for uninsured injuries varied from a few hundred dollars to millions of dollars; and
- 86 percent reported that the student-athlete had no out of pocket expenses for uninsured injuries.

Other Coverages

- 56 percent covered illness/medical that is unrelated to athletic program activities, most through student health centers.
- 31 percent provide coverage for athletic related injuries after the student-athlete leaves school or exhausts her or his NCAA athletic eligibility (duration not specified), while another 43 percent provide coverage under certain conditions (conditions not specified); and
- 87 percent do not provide enhancements to basic coverage like additional death benefits or higher policy limits.

NCAA Exceptional Student-Athlete Disability Insurance Program⁵⁶

In the early 1990s, the NCAA began a program to allow student-athletes with favorable professional prospects to protect their anticipated high future earnings from potential loss due to injury. The NCAA Exceptional Student-Athlete Disability Insurance Program began with participants in football and men's basketball and over the course of the decade expanded to include baseball, men's hockey, and women's basketball.

To qualify, the student-athlete must have NCAA athletic eligibility remaining in the applicable sport and have demonstrated professional potential, as follows:

- Football – selection in the first two rounds of the upcoming National Football League draft;
- Basketball – selection in the first round of the upcoming National Basketball Association or Women’s National Basketball Association, as applicable;
- Baseball – selection in the first round of the upcoming Major League Baseball draft;
- Men’s Hockey – selection in the first two rounds of the upcoming National Hockey League draft; or
- Other Sports – underwritten on a case-by-case basis.

If the student-athlete is determined to be eligible, she or he is deemed eligible for a premium finance loan. The loan must be repaid when the student-athlete signs a professional contract, a claim is made for a covered injury, or the coverage expires and the loan comes due.

The following maximum coverages apply:

- Football – \$10 million;
- Men’s Basketball – \$10 million;
- Women’s Basketball – \$250,000;
- Baseball – \$5 million;
- Men’s Hockey – \$3 million; or
- Other Sports – underwritten on a case-by-case basis.

This program only insures against total disability;⁵⁷ it does not provide benefits based on partially reduced professional earning capacity (i.e., if the insured signs a professional athletic performance contract in any amount, there is no coverage). The insured student-athlete must prove permanent total disability, based on specified criteria,⁵⁸ or qualify for a presumptive disability benefit.⁵⁹

Effect of the Bill

Compensation for Name, Image, Likeness, or Persona

CS/CS/HB 7051 authorizes intercollegiate athletes⁶⁰ to earn compensation for their name, image, likeness, or persona (NILP).⁶¹ The bill seeks to preserve the integrity, quality, character, and amateur nature of intercollegiate athletics while maintaining a clear distinction between amateur intercollegiate athletics and professional sports by:

- Providing that compensation for athletic performance or attendance at a particular institution remains prohibited.

- Prohibiting a postsecondary educational institution, an entity whose purpose includes supporting or benefitting the institution or its athletic programs, or an officer, director, or employee of such institution or entity from compensating or causing an intercollegiate athlete to be compensated for his or her NILP.

The bill prohibits postsecondary educational institutions receiving state aid, including Florida College System institutions, State University System institutions, and private colleges and universities, from:

- Preventing or unduly restricting an intercollegiate athlete from earning NILP compensation.
- Preventing or unduly restricting an intercollegiate athlete from obtaining professional representation for purposes of seeking NILP compensation.
 - For such professional representation, an intercollegiate athlete may retain an athlete agent licensed in Florida or an attorney licensed and in good standing with the Florida Bar.
- Revoking or reducing grant-in-aid awards for an intercollegiate athlete who earns compensation for his or her NILP.

The bill specifies that the terms of a contract for NILP compensation may not materially conflict with the terms of the intercollegiate athlete's team contract or extend beyond the time of the athlete's participation in an athletic program at a postsecondary educational institution. Athletes under 18 years of age must have any such contract reviewed by a court.

Additionally, the bill allows an athlete agent or attorney to represent an intercollegiate athlete in securing compensation for use of her or his name, image, likeness, and persona under s. 1006.74, F.S., regardless of athletic conference or collegiate athletic association rules, bylaws, regulations, and policies to the contrary.

Insurance Requirements and Scholarship Protection

The bill requires each postsecondary educational institution receiving state aid to:

- Provide intercollegiate athletes with health and disability insurance, including the cost of deductibles, coinsurance, and copays and a death benefit of \$25,000.
- In the event of a sports-related injury, continue providing such insurance for the duration of the time it takes the athlete to recover from the injury. Injuries must be timely reported, and the right to benefits ends if no benefits are necessary for 2 years.
- Maintain grant-in-aid (i.e., scholarships) for intercollegiate athletes for:
 - Up to one academic year or until the athlete completes their primary undergraduate degree, whichever is shorter, when the athlete has exhausted athletic eligibility.
 - Up to five academic years or until the athlete completes their primary undergraduate degree, whichever is shorter, when the athlete is determined to be medically ineligible to participate in athletics due to an injury that occurred while participating in an athletic program.
- Conduct a financial and life skills workshop at the beginning of the intercollegiate athlete's first and third academic years. The bill prohibits providers of financial products or services to market, advertise, refer, or solicit intercollegiate athletes during these workshops.

The bill directs the Board of Governors and the State Board of Education to adopt regulations and rules to implement the provisions of the bill.

IV. AMENDMENTS/ COMMITTEE SUBSTITUTE CHANGES

On February 6, 2020, the Education Committee adopted two amendments and reported the bill favorably as a committee substitute. The amendments:

- Clarified that insurance deductibles, coinsurance, and copays for insurance secured by the athlete (or the athlete's immediate family) must be paid by either the postsecondary educational institution or an association of which the institution is a member.
- Prohibited providers of financial products or services to market, advertise, refer, or solicit intercollegiate athletes during required financial literacy and life skills workshops.

On February 12, 2020, the Judiciary Committee adopted a strike-all amendment and reported the bill favorably as a committee substitute. The amendment:

- Titled the bill the "Intercollegiate Athlete Bill of Rights."
- Amended the statute created by the bill to s. 1006.74, F.S.
- Provided an entity whose purpose includes supporting or benefitting a postsecondary educational institution, or an officer, director, or employee of the institution may not compensate or direct another person to compensate a current or prospective intercollegiate athlete.
- Provided an intercollegiate athlete may not enter into a contract if the contract materially conflicts with the intercollegiate athlete's team contract.
- Removed a provision of the bill that prohibits a postsecondary educational institution from being a member of an organization that has policies or rules inconsistent with the bill.

The bill analysis is drafted to the committee substitute as passed by the Judiciary Committee.
